### Sending NZ Troops to Ukraine?



New Zealand Prime Minister Christopher Luxon claims he's prepared to send Kiwi troops into Ukraine for peacekeeping.

In an exclusive sit-down interview with Sky News, the leader made it clear Ukraine shouldn't concede land to Russia as part of a peace deal.

"If it was me and I'd been attacked by a big power and pummelled for three years, I'm not sure I'd be wanting to concede much of New Zealand to anybody," Mr Luxon told Sky News Australia.

When Mr Luxon was questioned about whether he'd consider sending troops to Ukraine for peacekeeping, he claimed he was "open" to it. Thanks to Penny Marie for sharing this. You can see the interview [here](#).

## Providing Safe Drinking Water a Legislative Requirement



On Tuesday the High Court in Wellington heard Whangarei District Council's (WDC) application seeking an interim injunction to allow the council to delay starting fluoridation until their substantive case is heard later in the year. Under an Amendment to the Health Act that

came into force in 2021, the Director-General of Health (DGoH) ordered WDC in July 2022 to start fluoridation by 28th March 2025.

WDC lawyer, Jeremy Browne, told the court that WDC were between a rock and a hard place. He said the council has been ordered to start fluoridation under one law, but to do so would cause the council to act unlawfully under another law. The Water Services Drinking Act (2021) requires councils to provide “safe” drinking water. “Safe” in relation to drinking water, means drinking water that is unlikely to cause a serious risk of death, injury, or illness. Providing safe drinking water was a legislative requirement. Read more [here](#).

## Dr. Sam Bailey Ordered to Pay \$148K, Loss of Licence

After training and practising within the medical system for two decades, health educator Dr. Sam Bailey commenced a new phase of understanding and promoting health as a wider concept.

Bailey had her medical registration cancelled and has been ordered to pay more than \$148,000 after standing up and reporting on her YouTube channel, which had about 18 million views.

## Standard & Poor's (S&P) downgrades credit ratings of 18 local councils

Credit rating agency Standard & Poor's downgraded the credit ratings of 18 New Zealand local councils and three council-controlled organisations (CCOs).

The decision was made in light of increasing cash deficits and unexpectedly high debt levels as councils struggled to generate revenue to cover rising costs, particularly in infrastructure. It said the downgrades could lead to higher borrowing costs, potentially impacting councils' ability to fund essential services and projects.

Meanwhile, Western Bay of Plenty District Council voted to quit Local Government NZ (LGNZ) by a narrow majority of six to five. Councillor Tracy Coxhead told the RCR Bites team that LGNZ was “not reading the room” and had “wandered too far to the left, enabled and encouraged by the last Government”.

Previous council departures from LGNZ included Christchurch City, Auckland, West Coast Regional, Grey, Kaipara and Westland District. Read more [here](#).

## Call to Create 'NZ's DOGE'



Callaghan Innovation has suggested that Parliament should create a "Government department expenditure tracking system" similar to the US Department of Government Efficiency (DOGE). The proposal would utilise blockchain technology to record official spending on a publicly available ledger, improving transparency. However, the initiative has faced criticism from University of Otago lecturer, Dr Olivier Jutel, who raised privacy concerns and called it “highly ideological”.

Callaghan Innovation, a soon-to-be disestablished government science research entity, is launching a challenge for people to create job-cutting software. It put the appeal out earlier this month calling for the creation of a "government department expenditure tracking system"



that would be "New Zealand's DOGE". "All government departments would be subject to storing their expenditure on a distributed ledger with a publicly available reason for the expenditure," Callaghan Innovation's appeal said. Read the rest of this story [here](#). Thanks to [RCR](#) for the link.

The newly released documents on the JFK assassination, while not revealing a single "smoking gun," do shed more light on various facets of the assassination saga. Notably, some files show that government agencies withheld or struggled with information during the original investigation. For example, a newly declassified CIA memo contains a 1964 interview with a CIA employee about inconsistencies in what the CIA and State Department told the Warren Commission regarding Americans in the Soviet Union. This suggests the Warren Commission

'Do you identify your baby as a transgender male/trans man/female to male,' parents in New Jersey were asked.

The bizarre inquiries into the newborns' sexual identities were part of a health provider's questionnaire distributed to numerous hospitals throughout New Jersey.

According to The Telegraph, the surveys created by Inspira Health asked, “Do you identify your baby as a transgender male/trans man/female to male”, with additional options for “genderqueer” and an “additional gender category.” The surveys also asked to know whether babies were “lesbian or gay,” “heterosexual,” “self-describes” or is “questioning/unsure.” Health care provider Inspira Health said the survey was required by New Jersey law, but that parents were “permitted to decline to provide” the data.

HHS Secretary Robert Kennedy is eliminating the self-affirmation process when companies introduce new ingredients in foods. Going forward, these companies need to publicly notify the FDA of their intended use of such ingredients, along with underlying safety data, before they are introduced in the food supply. *“For far too long, ingredient manufacturers and sponsors have exploited a loophole that has allowed new ingredients and chemicals, often with unknown safety data, to be introduced into the U.S. food supply without notification to the FDA or the public,”* said Secretary Kennedy. *“Eliminating this loophole will provide transparency to consumers, help get our nation’s food supply back on track by ensuring that ingredients being introduced into foods are safe, and ultimately Make America Healthy Again.”* - <https://www.thefocalpoints.com/p/rfk-moves-to-close-gras-generally>

President Donald Trump signed a memorandum on March 18 removing diversity, equity, and inclusion policies from foreign service positions. ## Doctors to be gagged under new Health NZ rules

### Clarifying accusations of public health “overreach”

Good morning,

1. The Free Speech Union is a registered trade union with a mission to fight for, protect, and expand New Zealanders’ rights to freedom of speech, conscience, and intellectual inquiry. We believe that freedom of speech is not only a legal principle, but a social good that allows for people in modern liberal democracies to peacefully, freely advocate for the causes they care about without risking unjust retribution.
2. We are aware that you held a meeting with medical officers on Tuesday this week, and that at that meeting you “reminded them that all potential local or regional technical advice is to continue to be reviewed and approved at a national level before they can be submitted.” We understand that you are seeking to shift the primary focus of public health away from advocacy efforts, and towards more technical issues in public health.
3. Commentators argue that this approach will create a “chilling” effect in the professional environment, which is exacerbated by those implementing ongoing job losses and cost cuts, thus increasing professionals’ sense of employment vulnerability.
4. It is critically important that healthcare practitioners operate in an environment in which they feel freely able to express their professional opinion and engage in professional debate. The Free Speech Union maintains an ongoing concern about a culture of fear amongst practitioners in the healthcare profession. Last week, we wrote to Minister Simeon Brown, noting concerns about an increasingly conformist culture across healthcare professions, which prioritises acceptance of dominant perspectives over the maintenance of a culture of free and open discourse about best professional practice.
5. We seek your clarification on the following:
6. Can you clarify the council submissions process, and your intentions in requiring sign off at a national level?
7. Can you provide assurance that the structure of this process will not contribute to an increasingly conformist culture in public health?

Updated rules from Health New Zealand would require a national-level “sign-off” before any doctor could make public comments on health issues. It had been common for doctors with relevant expertise to speak to the media or councils and advocate for public health issues, but

Dear President Trump,

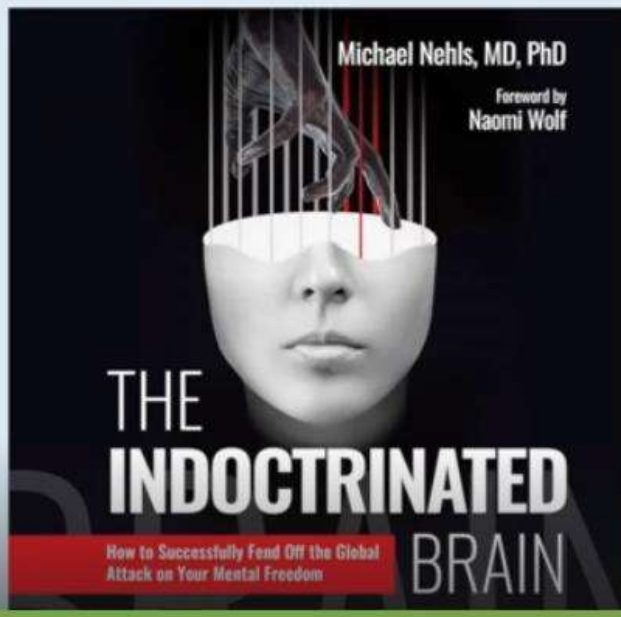

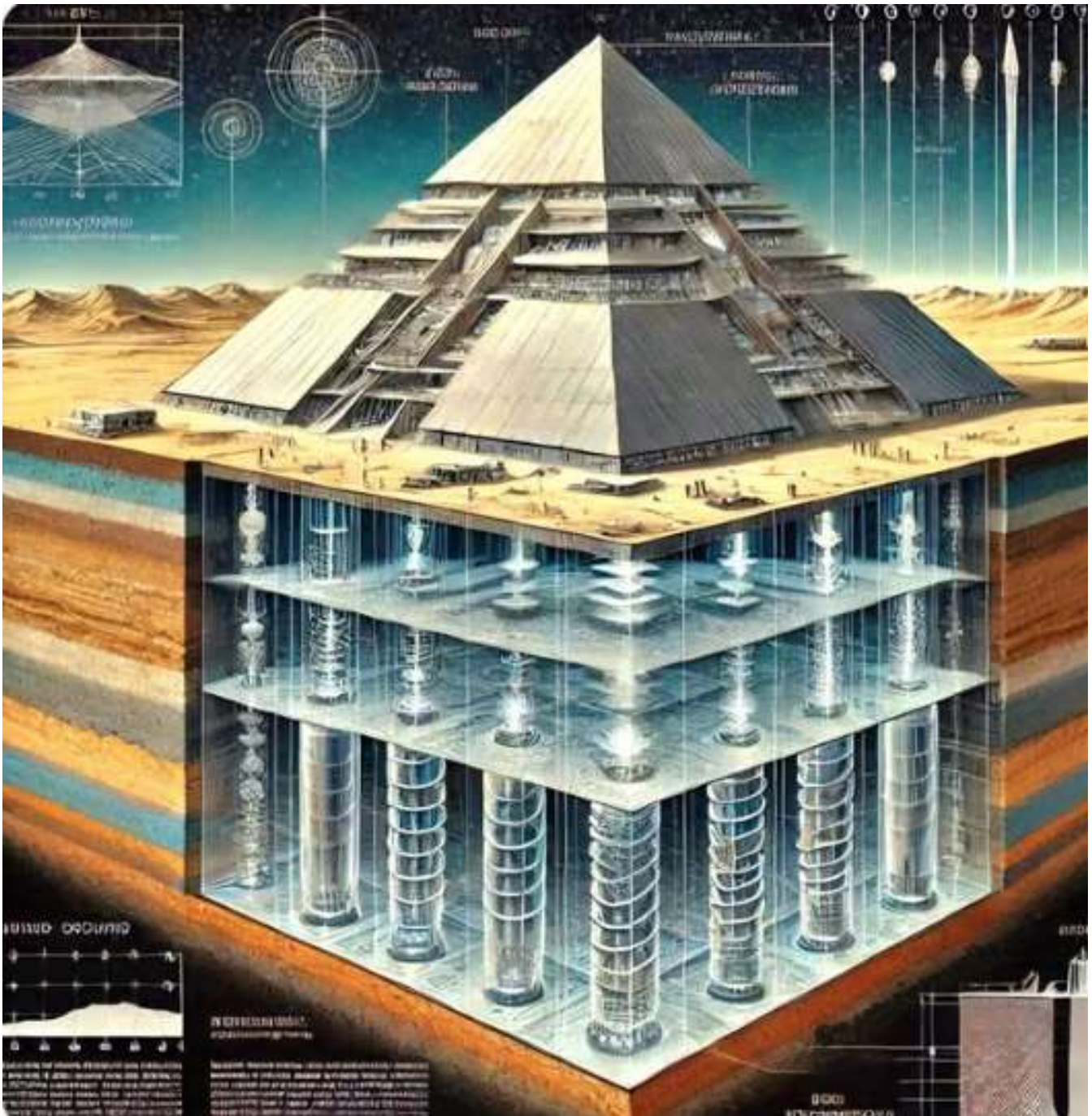

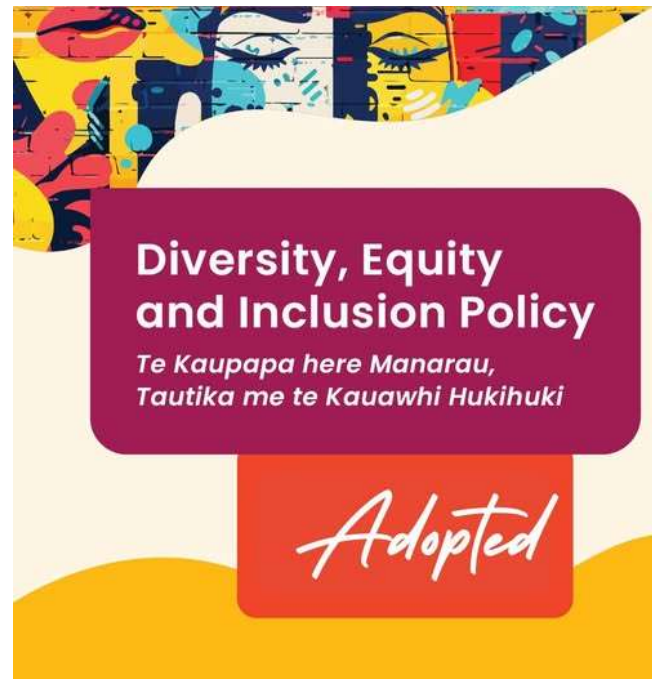
