## With So Many Parties 'Ruling Out' Working With Other Parties, is MMP Losing its Way?



There has been a lot of "ruling out" going on in New Zealand politics lately. In the most recent outbreak, both the incoming and outgoing deputy prime ministers, ACT's David Seymour and NZ First's Winston Peters, ruled out ever working with the Labour Party.

### Glyphosate to be Debated in High Court

The Environmental Law Initiative is challenging the Environmental Protection Authority's refusal to reassess glyphosate and glyphosate-based substances.

A judicial review hearing - which is expected to last two days from Monday - will see ELI challenge the EPA's 2024 refusal to reassess glyphosate and glyphosate-based substances. There had been significant scientific research on the herbicide since it was first introduced to New Zealand about 50 years ago, Environmental Law Initiative senior legal advisor Tess Upperton said.

That was the grounds ELI used in their formal request for a risk reassessment, but the EPA refused last year, prompting the judicial review set to be heard today and tomorrow.

Upperton said while the EPA had reviewed some aspects over the years, such as looking at carcinogenicity of glyphosate in 2015, there had never been a full risk assessment, which is the usual protocol when a new product is first approved for use.

"That's largely because it was first approved in the 1970s. We have asked the EPA for a record of that original risk assessment. They don't have a copy of that. They don't know what it is."

Since then, RoundUp and the more than 90 other glyphosate based formulas sold in New Zealand had been "grandfathered through successive regimes," she said, even though some of the glyphosate-based formulas have been found to have additional ingredients that amplify glyphosates toxicity. 



#### **Political**

Grant Abraham has announced his candidacy for Battle River—Crowfoot in the upcoming federal by-election, not as a politician, but as an Albertan ready to fight for our right to determine our own future. Montana Republican Gov. Greg Gianforte signed a new law eliminating onerous regulations on families who choose to homeschool their children. HB 778 repeals the requirement for homeschool parents to keep immunization records on their children and submit them with county superintendents. For Montana families who homeschool, HB 778 is a shift toward recognizing and respecting the unique nature of home education. Gianforte also signed laws to exclude biological males from women's restrooms, lockers, and showers, and to limit school athletic programs meant for girls to actual girls. Gianforte also repealed a mandate for "gender balance and proportional representation of minorities" in filling state government vacancies, effectively eliminating DEI ideology from state hiring; and most recently he banned activist banners such as LGBT "pride" flags from flying at government buildings.

Natural childbirth activist Gloria Lemay is finally released on bail. Lemay is accused of offering unauthorized midwifery services in B.C. and has been held in custody and denied bail since early January 2025. Lemay is 77 years old.

#### Medicine/Health

U.S. Secretary of Health and Human Services Robert F. Kennedy Jr. announced that the HHS is retiring all 17 members of the Centers for Disease Control and Prevention's vaccine advisory committee. Kennedy wrote - "Today, we are taking a bold step in restoring public trust by totally reconstituting the Advisory Committee for Immunization Practices (ACIP)." Kennedy noted that 13 of the 17 sitting ACIP members were appointed in the final moments of the Biden administration. Kennedy explained – "most members have financial ties to pharmaceutical companies marketing vaccines, or have worked with public health agencies to promote controversial vaccines, including the COVID-19, RSV and HPV shots." Kennedy wrote that the committee has "never recommended against a vaccine — even those later withdrawn for safety reasons." He said the committee has failed to "adequately scrutinize" vaccines for babies and pregnant women. During the **COVID-19** pandemic, Panagiotakopoulos actively

promoted COVID-19 vaccination for pregnant women. According to Dr. Ben Tapper - "There's no admission they got anything wrong — just silence and resignations."

#### Telling It Like It Is / Truth Bombs

Doritos, Froot Loops, M&Ms, Oreo cookies, Skittles, Gatorade, Mountain Dew and other popular snack foods and beverages may soon have to carry warning labels in Texas, if a "Iandmark bill," supported by U.S. Secretary of Health and Human Services Robert F. Kennedy Jr., is signed into law. Senate Bill 25 would require some foods and beverages sold in Texas to state that they are "not recommended for human consumption" if they contain ingredients that are banned or required to carry warning labels in the European Union, United Kingdom, Australia or Canada. The bill names 44 ingredients, including synthetic dyes, partially hydrogenated oils, bleached flour, and some seed oils and preservatives identified as contributing to the chronic disease epidemic in the U.S. by triggering increases in cardiac disease, diabetes, obesity, cancer and other conditions.




World Council for Health (WCH) submitted an application to become a UK Charitable Incorporated Organisation (CIO), but it has been turned down by the Charity Commission, citing concerns that WCH's purposes are not exclusively charitable, that its activities do not clearly provide a public benefit, and that some of its content and campaigns appear political, controversial, or lacking in evidence-based support.

#### The Application



A <u>Crux</u> complaint to the Chief Ombudsman has forced the release of a March 2025 survey that measures the level of community trust and confidence in the Queenstown Lakes District Council.

The survey only received 445 responses of which only 405 were "selected for reporting." QLDC does not explain the criteria for rejecting 40 responses.


