What we are doing

We're standing up for Kiwi independence by pushing for a citizens-initiated referendum to decide whether New Zealand should remain in the World Health Organization (WHO). This is about protecting our sovereignty and making health decisions that are right for us.

What is a citizens referendum?

It's your voice in action. By gathering enough public support, we can force Parliament to debate and take action on this issue, giving everyday New Zealanders a say in our future. A Citizens Initiated Referendum is different from an online petition. By law, all signatures must be in wet ink, meaning they have to be handwritten with a pen on the official forms we provide. Why should we consider leaving the WHO?

New Zealand's health policy should be determined by New Zealanders, based on the best available scientific evidence. However, membership in the WHO can compromise national sovereignty and subject New Zealand to international agendas that may not reflect our specific needs and values. The WHO's lack of transparency, potential conflicts of interest, and the influence of political factors on its scientific recommendations raise concerns about its ability to act in New Zealand's best interests. 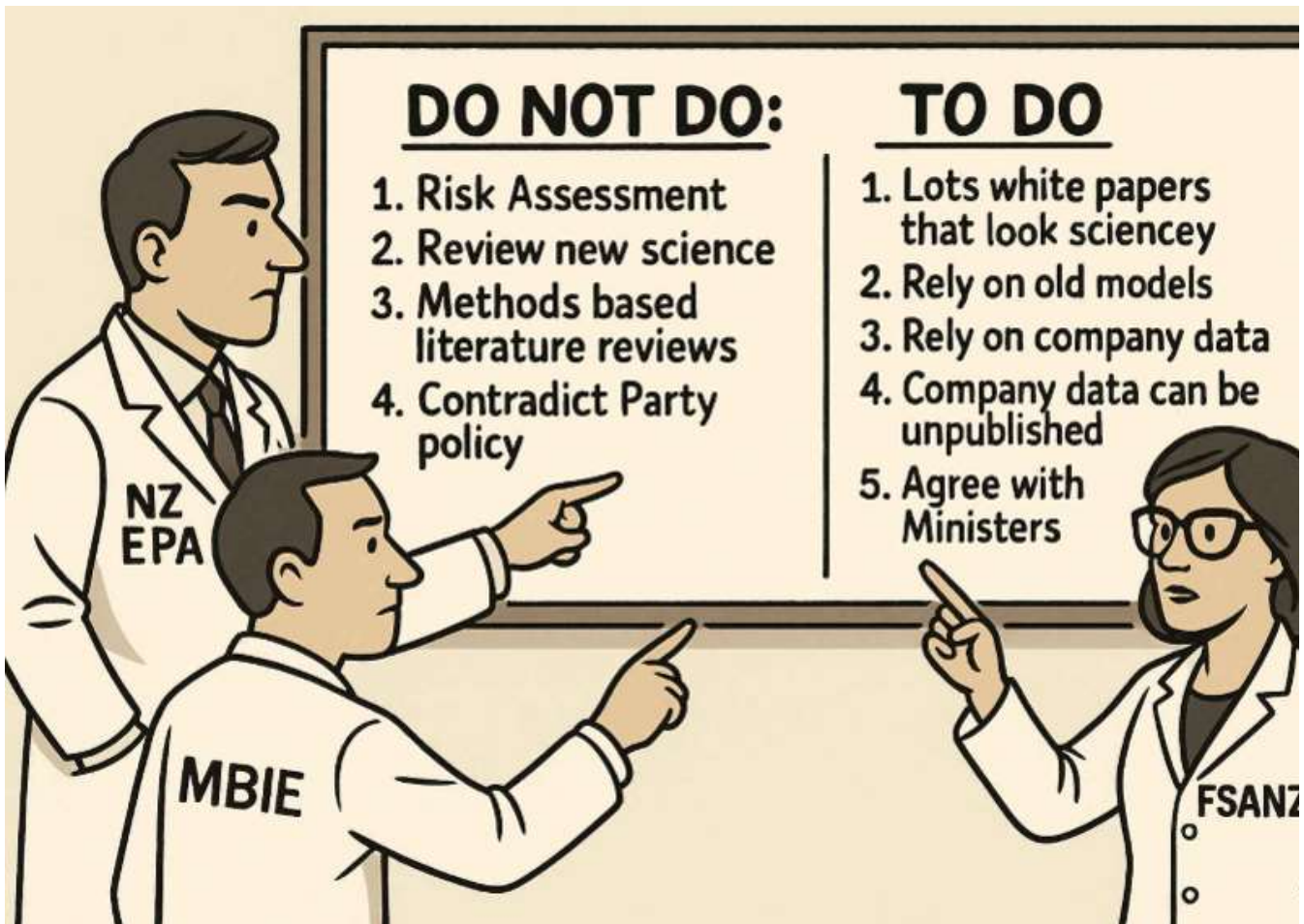
The NZ taxpayer-funded climate satellite MethaneSat has lost contact with the ground and “is likely not recoverable.”

“While this is difficult news, it is not the end of the overall MethaneSat effort, or of our work to slash methane emissions,” said a statement released by the Environmental Defence Fund (EDF), the US group behind the satellite.

MethaneSat was given \$29 million from the New Zealand Government, with the aim of growing the space industry. The mission’s goal was to name and shame oil and gas producers that were allowing planet-heating methane to escape into the atmosphere.

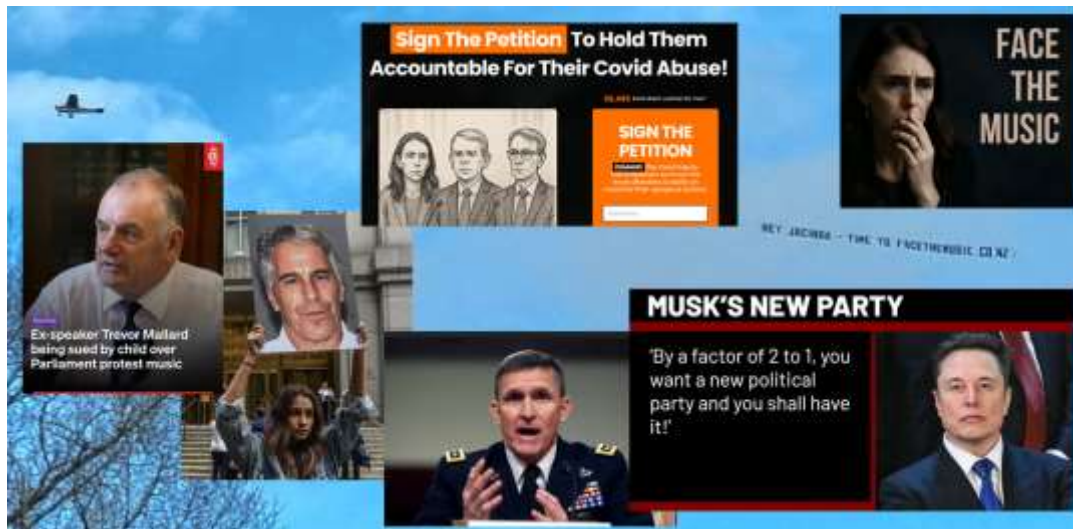
The question should be – is there anything in the world that can stem the New Zealand Environmental Protection Authority's (NZEPAs) decades-long backsliding?

MTG Introduces Bill Making Weather Modification a Felony in Bold Push Against Geoengineering

Rep. Marjorie Taylor Greene (R-GA) introduced bold federal legislation on Saturday aimed at outlawing geoengineering practices and banning the injection or release of chemicals into the atmosphere intended to alter the weather, temperature, or sunlight.

Greene's bill makes such acts a felony offense, targeting both private and government efforts to manipulate the climate through artificial means.

Political

The University of Pennsylvania has agreed to ban transgender women from women's sports, resolving a civil rights case that centered around swimmer [Lia Thomas](#) competing for the university's women's teams. Penn agreed to a number of actions to resolve what the department calls Title IX violations. Those items include restoring *"to female athletes all individual UPenn Division I swimming records, titles, or similar recognitions which were misappropriated by male athletes allowed to compete in female categories"*; issuing a public statement saying the university will comply with Title IX and will not *"allow males to compete in female athletic programs;"* and sending a *"personalized letter of apology"* to any female swimmers who were affected. The statement also said Penn Athletics locker rooms and bathrooms will be *"strictly separated on the basis of sex."* -

Legal

The Supreme Court on June 27 [ruled](#) that Maryland parents can, for religious reasons, opt their children out of school reading lessons that use LGBT-themed books. The ruling was 6–3. Justice Samuel Alito, writing for the majority, said forcing children to attend the reading sessions *"substantially interferes with the religious development"* of the plaintiffs' children and imposes an unacceptable burden on them. *"We reject this chilling vision of the power of the state to strip away the critical right of parents to guide the religious development of their children."* Parental watchdog group Moms for Liberty [celebrated](#) the decision saying - *"The Supreme Court just sided with parents over the authoritarian schools in Maryland that sought to FORCE elementary school children into explicit, sexual education against the will of their parents."* The dissenting justices, in an opinion by Sotomayor, said the majority's ruling gives parents too much power over educators. *"Today's ruling threatens the very essence of public education,"* she wrote. *"The Court, in effect, constitutionalizes a parental veto power over curricular choices long left to the democratic process and local administrators."* -

On June 27, 2025, the Supreme Court struck down the birthright citizenship loophole. The U.S. Supreme Court has ruled that birthright citizenship is not automatic. Medicine/Health

In an email this week, the author wrote: *"Advisers to the Centers for Disease Control and Prevention on June 26 advised the agency to stop recommending influenza vaccines containing a mercury-based preservative. Once flu shots that contain mercury are no longer 'recommended' by ACIP to my understanding that means that come off the 'schedule' for children and pregnant women and, therefore, they will no longer enjoy legal immunity under the NCVIA of 1986. Health Secretary Robert F. Kennedy Jr. is looking to revolutionize the Vaccine Injury Compensation Program that was established as part of the National Childhood Vaccine Injury Act of 1986. The Oklahoma State Department of Health has removed its recommendation that fluoride be added to public water systems, joining a growing number of states that have rolled back similar guidance. An executive order issued by Gov. Kevin Stitt [said](#) that there is *"growing public concern, evolving scientific research, and fundamental principle of informed consent that call into question the continued appropriateness of mandatory fluoridation of the public drinking water system."* The order directs state health and environmental officials to *"immediately cease any state-level promotion or endorsement of fluoridation of the public*

Most fluoride used in U.S. public water systems is not pharmaceutical-grade but rather industrial by-products: Hydrofluorosilicic acid, sodium fluorosilicate, and sodium fluoride are the most common additives. These compounds are often recovered from phosphate fertilizer production. Instead of being treated as hazardous waste, these by products are purified and sold to municipalities for water fluoridation. Because these fluoride compounds are not allowed by the EPA to be dumped directly into the environment, selling them for water fluoridation has been seen by critics as a form of “waste repurposing.

According to a recent ICAN newsletter, a Japanese studies reveals that natural exposure to measles and mumps and no MMR vaccine reduces the risk of heart disease. The study proves nearly 200,000 individuals would not die year over year of heart disease had they not received the MMR vaccines. Global New has done an extensive investigation into Canada's Vaccine Injury Compensation program and the results are disturbing. There have been 11,702 reports of serious adverse events following a COVID-19 vaccination, according to Health Canada. In our supposedly 'free countries', there is an obligation to obtain valid voluntary informed consent for vaccination, and any vaccinator who hasn't obtained valid consent, which isn't possible from someone who is being incentivised, pressured, coerced, manipulated, mandated to comply, could very well be accused of battery and clinical negligence. Vaccinators have been failing in their duty to properly inform the public about vaccination, and to protect their free choice for the medical intervention of vaccination. In spite

of this obligation, the College of Health Care Professionals of BC (which regulates audiologists, dietitians, hearing instrument practitioners, occupational therapists, opticians, optometrists, physical therapists, psychologists, and speech-language pathologists) has just released their proposed changes to their bylaws. The College is proposing a new provision that will make it a condition of licensing that proof be provided that the professional *"has received all mandatory vaccinations against transmissible illness required by or under an enactment,"* There is no requirement that the illness be harmful or severe, just transmissible. The enactment of the government will determine which vaccinations will be mandatory.
