

## Vietnam to Ventilation: Sisters Go on 18th Birthday trip, One Ends Up in ICU

What was meant to be an adventurous trip to Vietnam to mark a milestone birthday led to a teenager ending up in intensive care, unable to see and needing help to breathe. Auri Law left for Vietnam a few weeks ago to celebrate her 18th birthday with her older sister Caea before tragedy struck and she discovered she may have a "very rare neurological condition".

Auri's mother, Staci Law, told the Herald she rushed over on last-minute flights a few days ago to be with her daughter after an anxious wait.

"As a mother, I just want to take away the physical and emotional pain I saw my baby go through today. And I couldn't. I feel defeated," Law said on a Givealittle update today. A Givealittle was set up to help the family with flights to get her sister home, Mum to Vietnam and any costs not covered by medical insurance. Any excess funds will go towards medical costs for Caea and Auri once they return to New Zealand, such as therapy and treatments. 
## Prominent NZ Businessman Convicted of Sexually Abusing Three Men, Named

## An Inspiring and Powerful I'L Summit





The World Health Organization's amended International Health Regulations threaten national sovereignty, require nations to censor their citizens for "misinformation" and "disinformation," and support the rollout of an international digital ID that could be used as the technical platform for the imposition of a Chinese-style social credit system worldwide. 

Sen. Richard Blumenthal, a staunch vaccine supporter, said he was "heartbroken" after hearing parents recount how their once-healthy children were injured or killed by vaccines delivered during Tuesday's U.S. Senate hearing, "Voices of the Vaccine Injured." The senator suggested he may be willing to look into the issue of whether pharmaceutical companies should be held liable for injuries caused by their products. Blumenthal said he is "extremely suspicious" when an industry is given liability protection. Sen. Cory Booker introduced the <u>Pesticide Injury Accountability Act of 2025</u>. The proposed bill would amend the existing <u>Federal Insecticide</u>, <u>Fungicide</u>, <u>and Rodenticide Act</u> law to ensure that agrochemical manufacturers can be held accountable if their products harm human health. Alberta is blasting the Liberals' latest immigration decision, warning it will further strain the province's overloaded housing and healthcare systems. In a <u>Tuesday news release</u>, Alberta Immigration Minister Joseph Schow said <u>the federal plan</u> to accept up to 10,000 new applications "at a time when provinces are already struggling," shows a disregard for provincial capacity." Schow said: "Immigration must be sustainable and aligned with provincial capacity and priorities. Children's Health Defence Attorney Ray Flores is suing U.S. Health Secretary Robert F. Kennedy Jr. for failing to establish a task force dedicated to making childhood vaccines safer, as mandated by federal law. The lawsuit alleges Kennedy is violating the National Childhood Vaccine Injury Act of 1986, which requires the secretary of the U.S. Department of Health and Human Services (HHS) to promote the development of safer childhood vaccines that cause "fewer and less serious adverse reactions" than existing ones. The act requires HHS to provide Congress with progress reports every two years. However, the safety improvement provision of the law has been ignored for 35 years. The lawsuit points out that since the law was passed in 1986, no HHS Secretary has ever submitted the required safety reports to Congress. Deborah Conrad, a Physician Assistant, who was fired from Rochester Regional Health for reporting vaccine adverse events has been vindicated by a federal court. On June 11, 2025, the U.S. District Court for the Western District of New York issued a landmark ruling for Conrad in her case against Rochester Regional Health and United Memorial Medical Center. Judge Sinatra denied the hospital's motion to dismiss, letting her case go to discovery. Here's what this means: Rochester Regional Health had a material obligation to report serious adverse events to VAERS under their Provider Agreement with the CDC; The hospital's failure to report while continuing to seek federal reimbursement was potential fraud against the government; Her retaliation claim can move forward - the court found she was probably fired for trying to expose the hospital's failure to report adverse events. This decision establishes critical legal precedents: VAERS Reporting is Not Optional: The court confirmed that adverse event reporting requirements are "material conditions of payment" - not just bureaucratic paperwork. Hospitals Can Be Held Accountable: Healthcare providers who take federal money while failing to meet safety reporting obligations can face False Claims Act liability. - https://www.covidlawcast.com/p/covid-accountability-victory-court

Texas Attorney General Ken Paxton launched legal action against the U.S. Masters Swimming organization last week after it allowed male athletes who identify as women to compete at a women's spring meet in San Antonio. Paxton's July 16 suit contains five counts of legal allegations against USMS, stating that it "undermined the trust of consumers through false, deceptive, and misleading practices." Thanks to the ardent efforts of the legal team with ICAN, over 600,000 pages of Emergency Use Authorization (EUA) data that FDA used to authorize and then approve Pfizer's COVID-19 vaccine are now available to the public. After FDA approved Pfizer's COVID-19 vaccine in August 2021, ICAN attorneys won a lawsuit against the FDA for all data used to license the vaccine. The FDA produced over a million pages of records. However, upon closer look, attorneys discovered that FDA left out data relating to the vaccine's EUA file— an additional 600,000+ pages of vital information on the COVID-19 vaccine trials. In late 2024, ICAN attorneys went back to court to demand that FDA provide full transparency and produce the EUA file. The judge agreed. The final batch of EUA data was received at the end of June and

ICAN is proud to make it available to the public. Interested parties can visit the ICAN website to download the documents.

**The Democracy Fund** (TDF) in Canada has achieved a legal victory for a group of Amish individuals convicted under the Quarantine Act for failure to complete the ArriveCan app. Following a May 22, 2025 court appearance, seven months of negotiations and numerous court appearances, TDF lawyers successfully had the group's convictions set aside, resulting in over \$38,000 in fines being waived. -

The Democracy Fund is voicing concern that the government's study on misinformation will be used to restrict free speech. The Canadian government recently announced the results of a study entitled "Concern about misinformation—connections to trust in media, confidence in institutions, civic engagement and hopefulness, 2023/2024." The study purported to investigate online "misinformation." The study positions the increase in online "misinformation" as a problem that needs solving, presumably by government intervention. Conservative MP Leslyn Lewis sounded the alarm on Monday after Canada failed to reject amendments to the World Health Organization's International Health Regulations, warning these upcoming changes would undermine Canadian sovereignty. She criticized the federal government for not holding parliamentary discussions on the matter, despite the potential impact on Canada's ability to manage public health crises independently. "These amendments grant the WHO influence over Canada's public health response during global emergencies," Lewis said on X. "Canadians deserve a government that cares about protecting our national sovereignty." 
