FBI to open standalone office in Wellington



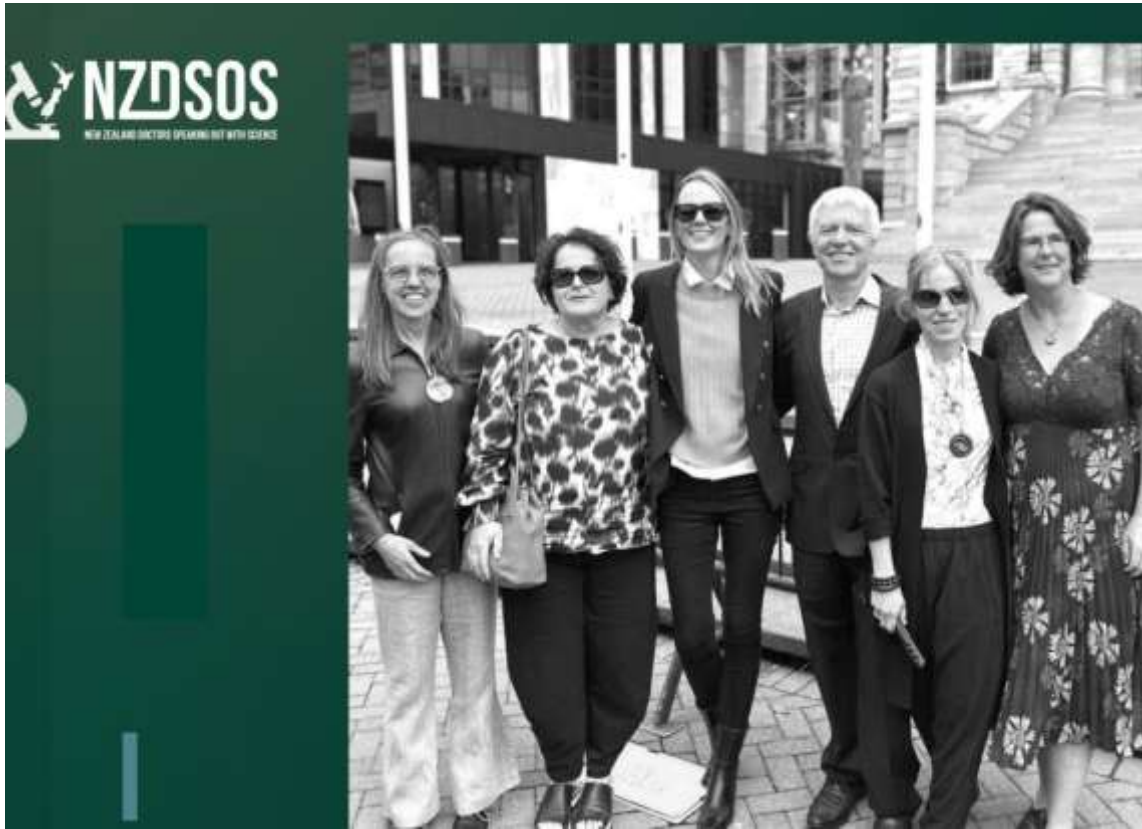
The FBI will be setting up a permanent office in New Zealand's capital, after the director Kash Patel met with several ministers, the heads of the police and New Zealand's spy agencies. The US Embassy in Wellington confirmed in a statement plans for a "dedicated law enforcement attaché office" in the city.

"While the FBI has stationed personnel in New Zealand for several years, establishing a full Legat position in the country will strengthen and enhance the long-standing cooperation with a key Five Eyes partner in the southwestern Pacific region," the statement said.

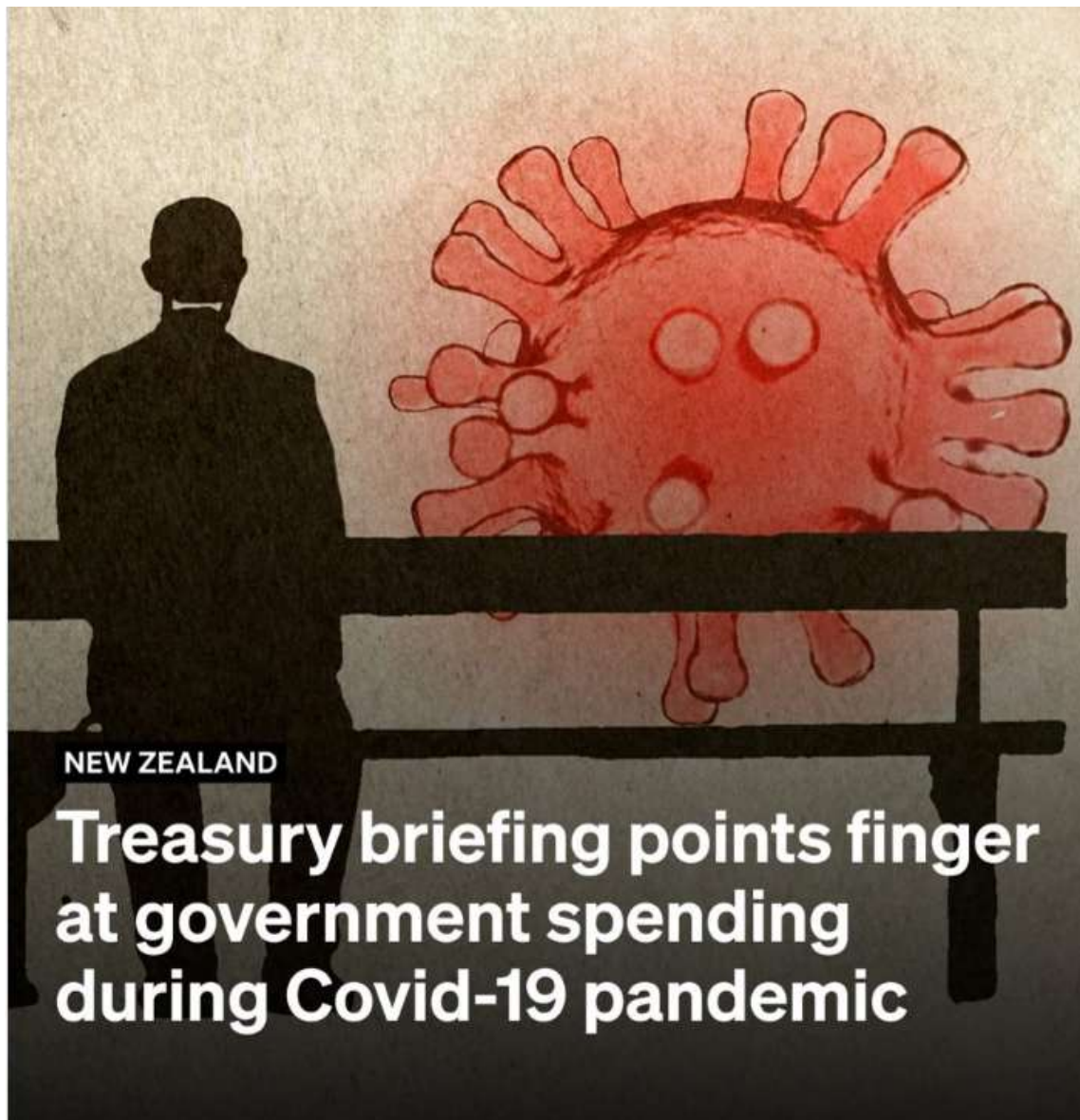

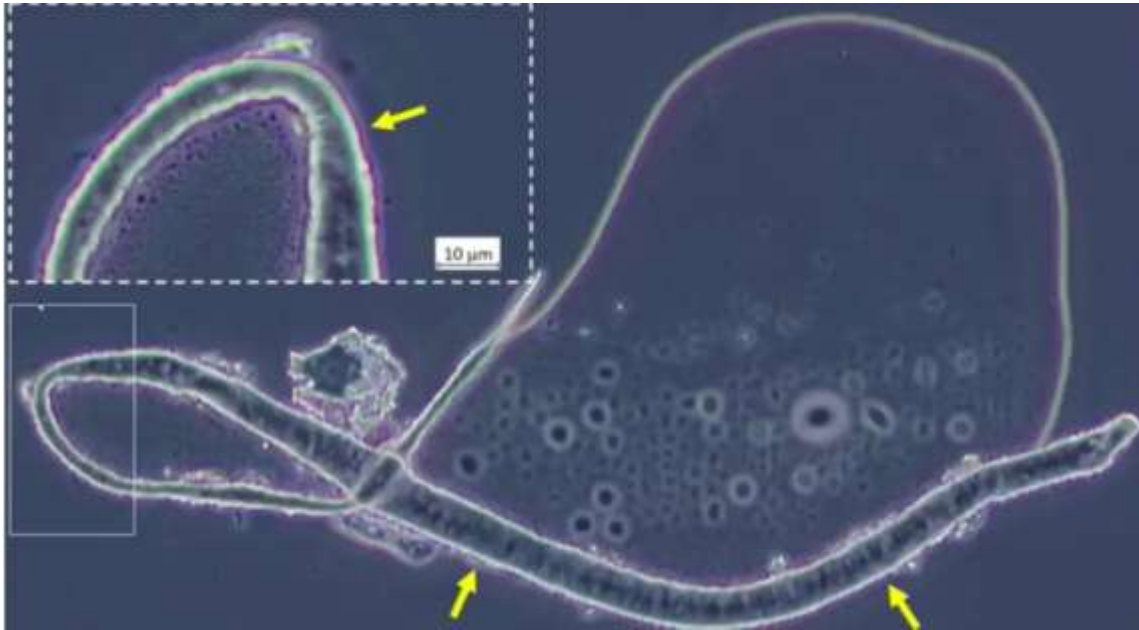

If you drive a private car in Oxford you may need to change your journey if you don't have a permit. The location of each filter has been chosen to help reduce congestion in and around Oxford. The six filters will work together to reduce traffic on the city's roads.

"At each traffic filter site, automatic number plate recognition (ANPR) cameras will monitor and enforce the restrictions. There will be no physical barriers.

Each filter will cover a very short section of road (just a few metres). Cars can use the road outside of the filter point at any time without a permit.

On July 23, 2025, President Trump signed his executive order **"Preventing Woke AI in the Federal Government."** The order mandates that federal agencies can only procure AI systems that adhere to strict *"Unbiased AI Principles"*—specifically requiring "truth-seeking" and "ideological neutrality." US Interior Secretary Doug Burgum signed an order on Aug. 1 to rein in "environmentally damaging" wind and solar power projects and ensure that federal lands are used optimally for energy initiatives. The Department of the Interior is legally required to ensure that land use decisions are "judicious." This requirement raises the question of whether allocating federal lands for wind and solar projects is permissible, given their high land requirement and the blockage of other land uses. The DOI stated that unreliable energy projects such as wind and solar are inefficient uses of land compared with coal, gas, and nuclear. Because there are alternatives that can generate the same amount or a higher amount of energy by using less federal land, power projects based on solar or wind power *"may unnecessarily and unduly degrade federal lands,"* according to the agency.

The **Independent Medical Alliance**, a coalition of physicians, healthcare providers, and researchers dedicated to science-driven healthcare reform, applauds HHS Secretary Kennedy and Dr. Mehmet Oz for **eliminating a regulatory rule** that effectively pressured hospitals to enforce COVID-19 vaccine mandates on healthcare workers. *“This is a major victory for medical freedom,”* said Dr. Joseph Varon, President and Chief Medical Officer of IMA. *“The prior policy created a perverse financial incentive for hospitals to mandate staff vaccination, regardless of individual health conditions, personal choice, or evolving science. The **U.S. Department of Health and Human Services** today announced the beginning of a coordinated wind-down of its mRNA vaccine development activities under the Biomedical Advanced Research and Development Authority, including the cancellation and de-scoping of various contracts and solicitations. The decision follows a comprehensive review of mRNA-related investments initiated during the COVID-19 public health emergency. *“We reviewed the science, listened to the experts, and acted,”* said HHS Secretary Robert F. Kennedy, Jr. *“BARDA is terminating 22 mRNA vaccine development investments because the data show these vaccines fail to protect effectively against upper respiratory infections like COVID and flu. We’re shifting that funding toward safer, broader vaccine platforms that remain effective even as viruses mutate.”* Going forward, BARDA will focus on platforms with stronger safety records and transparent clinical and manufacturing data practices. New Hampshire Gov. Kelly Ayotte signed into law two bills on Friday banning “gender transition” procedures for minor children. With her signature on Friday, New Hampshire has become the first New England state to outlaw transgender mutilation for children and teens. *“Medical decisions made at a young age can carry lifelong consequences, and these bills represent a balanced, bipartisan effort to protect children,”* said Ayotte in a statement. America’s apparent cultural shift away from “woke” ideology continues with reports that LGBT activist groups in multiple states are scaling back their “pride” events due to lower donations and less cultural receptiveness. Oklahoma-based “Bartlesville Equality” decided to postpone its entire “Pride 2025” event schedule because “fundraising efforts have not met the financial needs of Pride 2025.” “Austin Pride” in Texas similarly announced at the end of the month that it has “been impacted by the current political climate including funding.” New York City’s 2025 “pride” parade lost a reported \$750,000 in corporate sponsors, with businesses also withdrawing support for similar organizations. President Donald Trump confirmed that he will sign an executive order this week aimed at penalizing banks he claims have discriminated against conservatives, including him. For years, conservatives have accused banks of cutting off services for political or religious reasons. In April 2024, 15 state attorneys general issued a letter to Bank of America alleging that the bank *"appears to be conditioning access to its services on customers having the bank's preferred religious or political views."* The attorneys general charged that the bank employed ambiguous criteria to terminate banking relationships, such as reputational risk and allegations of promoting "intolerance" or "hate." *"Bank of America has denied services to gun manufacturers, distributors, and sellers; fossil-fuel producers; contractors for U.S. Immigration and Customs Enforcement; and private prisons and related services,"* the attorneys general wrote. The state of Tennessee passed one of the first-ever laws prohibiting political and religious discrimination by banks and insurance companies against state residents. Legal

Quebec's Superior Court has authorized a class-action lawsuit over infamous CIA-linked brainwashing experiments at a Montreal psychiatric hospital. The Royal Victoria Hospital, McGill University and the Canadian government are being sued for their alleged role in the so-called Montreal Experiments carried out by Dr. Ewen Cameron between 1948 and 1964. The lawsuit alleges the federal government funded psychiatric treatments that were part of the CIA's MK-ULTRA program of covert mind control at Montreal's Allan Memorial Institute. It says the treatments severely damaged the bodies and minds of patients, and included experimental drugs, rounds of electroshocks and sleep deprivation. Justice Dominique Poulin has identified as plaintiffs all the patients who underwent the experiments, as well as their immediate family, successors and dependants. The Ministerios Restauracion Church has received a ticket from the City of Montreal for allegedly using the Church for an "unauthorized purpose" when they hosted Sean Feucht. The ticket fine amount is \$2,500. A spokesperson for the Mayor's office stated that *"This show runs counter to the values of inclusion, solidarity, and respect that are championed in Montreal. Freedom of expression is one of our fundamental values, but hateful and discriminatory speech is not acceptable in Montreal."* Mark Joseph, litigation director for The Democracy Fund, responded that *"The state has apparently prejudged this matter, suggesting, improperly and without evidence, that peaceful Christian worshippers were engaged in hate speech. This is highly inappropriate and indicative of bad faith. Canadians have a right to a fair trial and a right to freedom of religion under both the Canadian Charter of Rights and Freedoms and the Quebec Charter of Human Rights and Freedoms."* Montreal lawyer for the Church, Olivier Seguin, stated that: *"False regulatory pretexts have been used by the authorities to hinder free speech and religious practice. However, the legal basis for the charge is flimsy. We intend to fight this matter in court and expect to bring Charter challenges for infringement of both freedom of religion and speech."*

NZ Petrol Tax to be Replaced With Road User Charges by 2027



Road user charges to expand to all vehicles, petrol tax to be scrapped

Transport Minister Chris Bishop said the Government would replace the petrol excise tax with electronic road user charges (RUC).

The result would be that petrol vehicles pay to drive on public roads using the same system as diesel and electric vehicles. Bishop said the relevant legislation would be passed in 2026, with full implementation expected by 2027.

Bishop described the policy change as the most significant roading reform in 50 years, as it would enable more accurate cost assessments of the demands that petrol vehicles place on the road network

From the Government Press Release:

Cabinet has agreed to a series of important legislative changes to enable the transition of New Zealand's 3.5 million light vehicles to paying for our roading network through electronic road user charges, rather than petrol tax, says Transport Minister Chris Bishop.

“The abolition of petrol tax, and the move towards all vehicles (whether they be petrol, diesel, electric or hybrid) paying for roads based on distance and weight, is the biggest change to how we fund our roading network in 50 years,” Mr Bishop says.

“Right now, New Zealanders pay Fuel Excise Duty (FED, or petrol tax) of about 70c per litre of petrol every time they fill up at the pump with a petrol car. Diesel, electric, and heavy vehicles pay Road User Charges (RUC) based on distance travelled. Read the full document [here](#).
