# Stop New Zealand's Electronic Road User Charges (eRUC) Surveillance System

Within the first 7 days, over 14,900 had signed the petition. The petition is related to the <u>Government announcement</u> of a Electronic Road User Charges (eRUC) system to replace fuel taxes.

Here's portion of the petition text:

"To: New Zealand Government, Ministry of Transport, Members of Parliament What's at Stake? The upcoming electronic Road User Charges (eRUC) system will use GPS and digital tracking to monitor vehicle movements for charging purposes. This means the government will collect detailed data on where, when, and how far every vehicle travels—affecting every driver in New Zealand.

### Why This Matters:

- 1. This system builds a massive surveillance framework that risks your privacy and freedom of movement.
- 2. Data breaches and misuse of such sensitive vehicle location data are real and documented risks.
- 3. It sets a precedent for linking vehicle tracking with government digital ID systems and Central Bank Digital Currencies (CBDCs), leading to unprecedented citizen monitoring and control.
- 4. Once in place, reversing this system will be extremely difficult, gradually normalizing constant government tracking.

### Marsden Point's Past, Present, Future




Marsden Point operated as New Zealand's only oil refinery for nearly 60 years.

At its peak in the 1980s, it employed about 1700 people. When it was closed in 2022, nearly 240 people lost their jobs.

The site, now run by Channel Infrastructure, operates as New Zealand's largest fuels import terminal, storing and distributing 40% of the country's fuel.



- 4. The duration of the suppression order.


I require the information for a submission to Parliament which is due on 18 September 2025. I look forward to hearing back from you.

### WINS OF THE WEEK

#### **Political**

A member of the U.S. Congress has **drafted legislation** that would strip federal funding from schools that don't allow parents to apply for religious exemptions from **vaccination** requirements for their children. The **GRACE Act**, or Guaranteeing Religious Accommodation in Childhood Education Act would target elementary and secondary schools, as well as local and state educational agencies. The legislation would not require state authorities or educational institutions to offer religious exemptions, but it would deny federal funds to those entities if they maintain **vaccine mandates** that don't include provisions for religious exemptions. The GRACE Act is a response to the "alarming erosion of civil rights" that occurred under the Biden administration, said Cait Corrigan, an advocate for medical freedom and religious liberty. - Source <a href="https://exemptions.org/liberty-new-color: blue times and the color of the

The Department of Government Efficiency has terminated 123 "wasteful contracts" over the past five days with a ceiling value of \$5.3 billion and savings of \$4.2 billion. As of Aug. 15, DOGE had saved an estimated \$205 billion for the federal government, amounting to \$1,273.29 saved per U.S. taxpayer. The DOGE website's Greatest Hits section said that among the "strangest, most baffling uses" of government funds <u>cancelled</u> by DOGE include a \$1.5 million grant to the Center to Advance Reproductive Justice and Behavioral Health

for "black pregnant/postpartum women and birthing people." Other cancelled contracts include a \$6.9 million grant for mental health development from "an antiracist approach" and a \$10 million award for "decolonizing the curriculum." - Source <a href="here">here</a>.

The Canadian Taxpayers Federation have a similar "greatest hits' section. It handed out 'Waste Awards' to politicians and bureaucrats who wasted our money in the dumbest ways. They sent out a survey asking who people thought should have "won" the Waste Awards. Here's what thousands of supporters said: About 90% said Trudeau is the most worthy recipient of this year's Lifetime Achievement Waste Award. About 40% picked Global Affairs Canada for spending \$51,000 per month on booze, \$8,800 on a sex toy show in Germany and \$12,000 on a show where seniors in other countries talked about their sex lives. A close second was Statistics Canada - 39%. It spent almost \$1 million making a podcast, but it wasn't about statistics ... #### Legal

The CDC's untested childhood vaccine schedule is on trial. Literally. On Friday August 15th, Rick Jaffe, Esq. filed a federal lawsuit on behalf of Dr. Paul Thomas, Dr. Kenneth Stoller, and Stand for Health Freedom. The lawsuit challenges the CDC's 72-dose childhood vaccine schedule on the grounds that it has never been safety tested as actually administered. The CDC had never tested the complete schedule for safety; and that the Institute of Medicine has been asking the CDC to do so for almost 25 years. The courts are being asked to force the CDC to change the childhood vaccine schedule from Category A recommendations, which include mandates, to Category B — shared decision-making between families and physicians — until the CDC does the testing its advisors have recommended for decades. Seventeen EU nations, the UK, and Japan already operate this way: no mandates. For decades, the agency has demanded proof of harm while refusing to do the studies that could provide it, and physicians who attempt to fill that research gap or challenge the schedule or ACIP's narrow contraindications and precautions framework are ridiculed and delicensed. Dr. Paul Thomas is one example. That era is over. If the CDC wants to claim the vaccine schedule is safe? Prove it. This case is 100% funded by the community. Check out the campaign: More here.

#### Medicine/Health

At the June meeting of the CDC's revamped **Advisory Committee on Immunization Practices** (ACIP), Dr Martin Kulldorff, the committee's new co-chair announced the committee was forming two new **work groups**. One group would look at the cumulative effect of the childhood and adolescent vaccination schedules, and another would look at **vaccines** that have not been reviewed in more than seven years. -More <a href="here">here</a>.

The CDC's new Covid-19 vaccine working group has released its Terms of Reference. The ACIP working group now has a mandate unlike anything the committee has ever undertaken. For the first time, federal advisers will investigate the unresolved issues that have dogged the vaccines since their rushed rollout in late 2020. From DNA contamination in the manufacturing process to the persistence of spike protein and mRNA in the body, from immune class switching following repeated boosting to safety in pregnancy, cardiovascular risks, and long-term disability, the list of questions is as sweeping as it is sensitive. -More here.

The Vaccine Reaction writes: "The loss of trust in the medical profession since 2020 is altering the misconception that American Academy of Pediatricians-like medical societies are primarily altruistic, dedicated to the welfare of others rather than their members." The recent publication of AAP priorities should reinforce this loss of trust. Their first priority is to

eliminate non-medical exemptions to vaccinating children. "The AAP will almost certainly continue its path of child polypharmacy, blind adherence to protocols based on the products of their sponsors, and denigration and exclusion of the opinions of parents who recognize the stark reality of deteriorating health in North American children. Parents reading the AAP's list of priorities would be foolhardy to then entrust their children to such care. Fundamental rights of each human to make their own way in life, and protect and oversee their children, underpin any decent societal model. In fascist societies, such decisions are removed and taken into the hands of experts and authoritarian institutions. The people must simply comply as slaves. Medical professions and their academies have a long history of supporting such approaches, and the AAP seems increasingly determined to replicate that path. It should receive all the respect that such an indecent approach deserves." - More here.

The relationship breaks with it. Truly solid relationships aren't bonded by agreement. They're built on respect for contrast... On curiosity about different beliefs and perspectives. When love is real... It isn't threatened by disagreement. It's deepened by it. Perhaps the real power isn't found in being constantly liked. Perhaps the true liberation comes from caring less about how we're perceived. Not to become cold to life or others... But to become free from the illusion of external validation."

#### Inspiration/Words of Wisdom

Inspirational words from Mikki Willis: "Over the past five years I've asked every dissenting doctor, scientist, and whistleblower the same question at the end of our interviews. "Do you have any regrets for speaking out?" Without hesitation... they all answered... "No." In fact the majority described what felt like a spiritual phenomenon. For the first time in their lives they were experiencing the kind of freedom that comes only from being in service to truth." Willis says: "I can relate. The moment I stopped playing it safe was the moment I was consumed by a peace I'd never known. It was Jesus Christ who said... "You shall know the truth... and the truth shall make you free." That's not just theology. It's a roadmap to liberation. So I ask you again... What are you still afraid of? Losing your job? Losing

customers? Losing friends? Here's what I've learned from being willing to lose all of that. That's when fate reveals itself. When you're truly in service to people... to truth... to life itself... something sacred happens. The benevolent forces of the universe step in."

## **Kiwi Ferns Rugby Star Dies While Taking Nap in Car**



A former NRLW Warriors star died while taking a nap in an Auckland McDonald's carpark after a long-haul flight from a rugby tournament in Japan, the coroner has revealed.

Fourteen-test Kiwi Ferns forward Kath Wharton (nee Keremete) was found unresponsive in her vehicle by her husband on November 21 last year. Despite efforts to resuscitate her, she was pronounced dead at the scene.

A post-mortem examination of the 41-year-old's body determined her cause of death was a sudden cardiac arrest, Associate Coroner Hannah Cheeseman said in her findings released publicly on Thursday.
