Lawyer punished for engaging in public dissent over local council conduct

We can also look to lawyer Kirsten Murfitt who has encountered backlash for speaking out against the conduct of her local council. Kirsten, a principal of her law firm, performs pro

bono work for Lobby for Good, a group raising concerns about a controversial land deal involving Tauranga City Council.

She was asked to write a public letter to the Minister of Local Government outlining concerns about the sale of ratepayer-owned land and alleged conflicts of interest involving a former council executive. She also recorded a podcast about the story, and both went on her social media.

What followed? Defamation threats, formal complaints, and the kind of professional pressure that makes others think twice before speaking out. Is this really about harm, or people using vague, oppressive laws to shut down criticism?

Kirsten offered to make things right if she had, in fact, defamed a council staff member involved. The complainant didn't take her up on the offer and instead doubled down.

Kirsten has legal representation already, but we're keeping in touch with her as the story develops.

Signing an open letter on matters of public interest should not get a lawyer in trouble. Yet again, the law is being weaponised against legitimate speech, undermining Kiwis' speech rights, and wasting time and resource in the process. Transparency is key for public trust, and the ability to criticise your local council is part of democracy; someone's career should not be threatened because of it. See the article [here](#). Your Brain on ChatGPT



Does ChatGPT make you stupid? MIT study suggests people who rely on AI tools are worse off.

On June 10, a group of MIT researchers released the preliminary results of a 4-month [study](#) that examined the cognitive impacts of using a large language model (LLM) AI tool — specifically, ChatGPT — during an essay-writing task. Led by [Dr. Nataliya Kos'myna](#), the study swiftly went viral, inciting alarmist headlines that reduced the 206-page paper down to declarations like "[ChatGPT erodes critical thinking skills](#)", "[MIT researchers say using ChatGPT can rot your brain](#)", and "[ChatGPT use linked to cognitive decline](#)".

While Kos'myna felt an urgency to release the study's results ahead of a formal peer review process due to the unprecedented rate at which AI tools are being adopted, she was also quick to reject singular, reductionist claims. In fact, her lab explicitly asks people — particularly journalists — to [avoid using phrases](#) like "terrifying", "stupid", "dumb", "brain rot", and "harm" when describing their findings.

Political

Florida Surgeon General Joseph Ladapo announced today plans to eliminate all vaccine mandates in the state, including for children to attend school. "The Florida Department of Health, in partnership with the governor, is going to be working to end all [vaccine mandates](#) in Florida," Ladapo said at a press conference in Tampa, hosted by Gov. Ron DeSantis. Florida would be the first state to completely drop all mandated vaccinations. [Ladapo said](#) every immunization requirement "is wrong and drips with disdain and slavery." "Who am I as a government? Or anyone else? Or who am I as a man standing here now to tell you what you should put in your body?" he asked. In 2023 he [issued a health alert](#) to the Florida healthcare sector and to the public, warning that COVID-19 mRNA vaccines caused a "substantial increase" in reports of adverse events in Florida. Last year, Ladapo called for a [halt in the use of COVID-19 mRNA vaccines](#) over safety concerns that the mRNA technology is delivering DNA contaminants into people's cells. He also played a key role in the decision for Florida to become the [second state to ban fluoride](#) in public drinking water. - More info [here](#).

The Alberta government has temporarily paused the implementation of its standards on sexually explicit content in school libraries, saying the directive needs revision after Edmonton Public Schools released a book removal list that the province says didn't reflect the policy's intended purpose. The list was shared online on Aug. 28 and included titles such as Margaret Atwood's "The Handmaid's Tale," Maya Angelou's "I Know Why the Caged Bird Sings," Aldous Huxley's "Brave New World," and books by authors like Alice Munro and Ayn Rand. *"I'm going to be more explicit than usual so there is no misunderstanding this policy: 1. Get graphic pornographic images out of school libraries. 2. Leave the classics on the shelves,"* Alberta Premier Danielle Smith said on social media. *"We all know the difference between the items in 1 and 2. Let's not play any more games in implementing this policy for our kids."* Smith said: *"if the school board needed the provincial government to 'hold their hand through the process,' the government would 'happily work with them' to identify material that is age-inappropriate for students."* - Read more [here](#).

President Donald J. Trump has finally signaled a reversal on Operation Warp Speed. James Bauder, [One of the organizers of the convoy protest](#) in Ottawa in 2022 faces a Canada-wide warrant after failing to appear in court earlier last week. Bauder is [the founder of Canada Unity](#), an organization that gathered signatures for a petition that called for governments to end all vaccine mandates, passports and other "discriminatory regulations and initiatives" and for a "cease and desist order" to be issued to elected members of parliament. Bauder fled to the U.S. earlier this summer and filed an asylum application on Aug. 5. He [claims he is being politically persecuted](#). Justice Charles Hackland said there is a legitimate concern about Bauder securing an unbiased jury yet still failed to permit the trial be moved out of Ottawa. - More info [here](#).

Paul Offit, long-time member of the FDA's vaccine advisory committee was recently informed by the Department of Health and Human Services that his services are no longer required. Health Secretary Robert F. Kennedy Jr. completely [overhauled](#) the CDC's vaccine advisory committee, but until now, the FDA's sister committee had largely been left unchanged. Paul Offit, director of the Vaccine Education Center at Children's Hospital of Philadelphia, had served for eight years on the FDA's Vaccines and Related Biological Products Advisory Committee and had agreed to serve for two more. On Tuesday he was informed his services will no longer be required. In May, when the FDA announced that all new vaccines are to be tested in placebo-controlled trials before they are approved, Offit responded - *"It's just anti-vaccine activism come to the policy side."* Also in May, Offit wrote an [open letter](#) to Sen. Bill Cassidy, chairman of the U.S. Senate Committee on Health, recommending that Kennedy step down as HHS Secretary. - More info [here](#).

These include the forced '[voluntary](#)' exile of Palestinians from Gaza and the sacrifice of remaining Israeli hostages in the pursuit of an [elusive 'total victory.'](#)" "As some of Israel's most ardent supporters, Orthodox Jews bear a unique moral responsibility. We must affirm that Judaism's vision of justice and compassion extends to all human beings. Our tradition teaches that every person is created in the Divine image," the letter reads. "Allowing an entire people to starve stands in stark contrast to this teaching." - [letter signed by a 80 Orthodox Rabbis](#).

RFK Jr to reveal autism causes

Kennedy is to reveal what he claims are the "causes" of autism at a news conference in September. Donald Trump's US health secretary launched an inquiry into the root of the neurological condition, which is widely believed to be at least partially influenced by genetics. During a lengthy Cabinet meeting on Tuesday, Kennedy said: "We're finding interventions, certain interventions now that are clearly, almost certainly causing autism. "And we're going to be able to address those in September."
