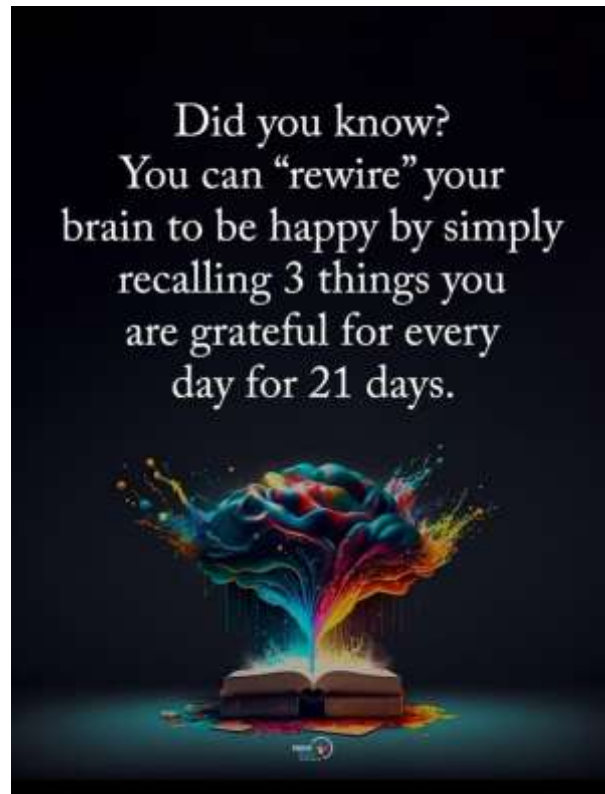

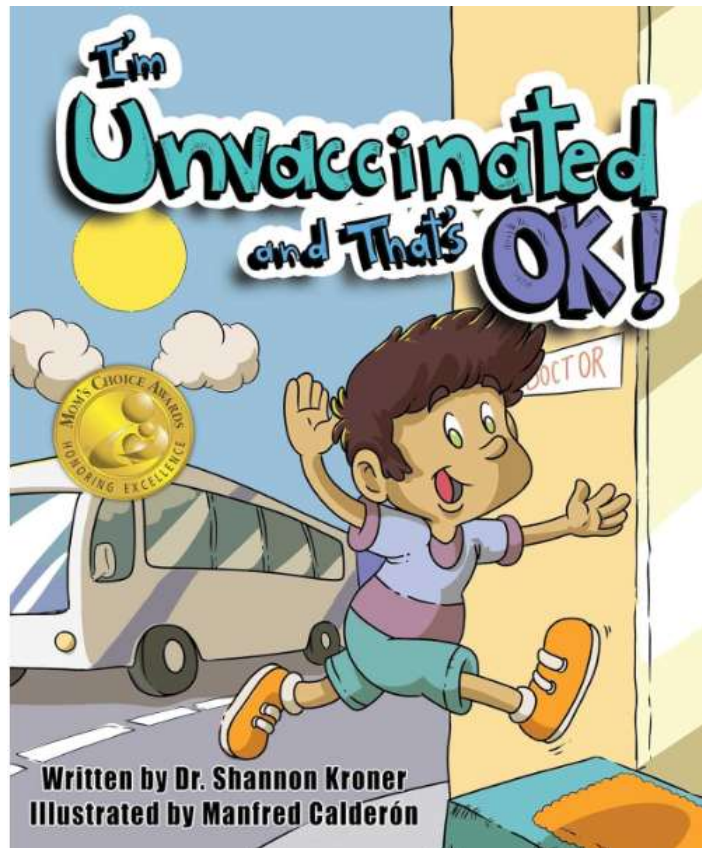

Protecting Public-Sector Whistleblowers Against Criminal Liability

The recent prosecution of Barry Young by the New Zealand government for disclosing confidential vaccine data serves as a stark reminder of the significant personal risks faced by public-sector whistleblowers. Due to the inadequacies and even outright failures of other methods of holding governments transparent and accountable, whistleblowing has become the last line of defence for safeguarding the public interest and ensuring government integrity. Accordingly, protecting public sector whistleblowers is not only a moral duty but also a practical necessity. This paper analyses current whistleblower protection laws in the Five Eyes countries and identifies several major problems within the existing regimes. In particular, whistleblowers may face criminal liabilities when they disclose government information to the public. Public-sector whistleblowers reveal government misconduct in the public interest. They do not deserve to go to jail. The paper argues for broad protection against criminal liability. Read this paper [here](#).

Have Your Say on The Dreaded Gene Tech Bill By Writing to NZ First

CFNZ along with Professor Jack Heineman presented a talk last month about the Gene Technology Bill. Please note that neither CFNZ nor Jack align with a particular political party in regard to the Bill.

The Bill is currently before Parliament. It passed its first reading last December. 15,000 submissions were received by Feb 17 with 400 being heard in person by the Health Select Committee. It is a complex and controversial bill, so much so that the Health Select Committee report has been delayed three times and is now due out the 10th of October. The Bill is at a finely balanced stage as to its outcome. NZ First recently announced they would not support the Bill without substantial safeguards being put in place. Proponents have upped the pressure on NZF to pass the Bill as drafted. At the meeting, Jack explained the fundamentals of the proposed Bill, how it differs to the old one and what the potential impact of some of these changes could mean for the health of our land, food chain and trade.

As NZF appears to hold the key to the outcome of this Bill, if you wish to take action Concerned Farmers NZ would encourage you to write to either Rt Hon Winston Peters and/or to Rural Affairs Minister Mark Patterson expressing your concerns. They need to hear what New Zealanders think before the second reading of the Bill, which is most likely soon after Oct 10/

Political

The Supreme Court has granted Universal Ostrich Farms in Edgewood, British Columbia an interim stay, thus preventing the federal government from carrying out a planned cull — for now. The news came just hours after the Ktunaxa Nation offered their support by arguing that the farm sits on ancestral territory, and as such, the Canadian Food Inspection Agency must consult with them before even considering slaughtering the nearly 400 birds. Katie Pasitney, one of the ostrich farmers, told RCMP Wednesday morning that the Ktunaxa had signed on to help the night before. *"The ostriches and our land are now under the protection of the signatory Indian Tribe,"* she said while handing officers a cease and desist. *"This needs to go to the higher-ups."* The officers said they would make sure it got to the relevant people. - <https://www.westernstandard.news/news/breaking-bc-ostrich-farm-granted-interim-stay-by-supreme-court/67782>

Amidst a firestorm of criticism over the Liberal government's looming gun confiscation program, the Alberta government has instructed police within its jurisdiction to focus on other priorities. Alberta's Minister of Justice Mickey Amery and Minister of Public Safety and Emergency Services Mike Ellis made the provincial government's position clear. *"Simply put, Alberta's government will not be enforcing this gun grab, and we will make clear to law enforcement that this is not an enforcement priority. For the first time in America's history, the US federal government is investigating ALL potential causes of autism. The lawsuit was filed after a high school student was expelled after his parents asserted a religious objection to the state's mandatory school vaccinations. The District Attorney then initiated truancy proceedings against the parents. They are asking the U.S. Supreme Court to review the petition on an emergency basis, so that they can return their child - and all similarly situated children in California - to the classroom. This is not just about California. A victory in this case could restore religious liberty from mandatory vaccinations for every student in the country, including those in several other states that currently do not have religious exemptions. -

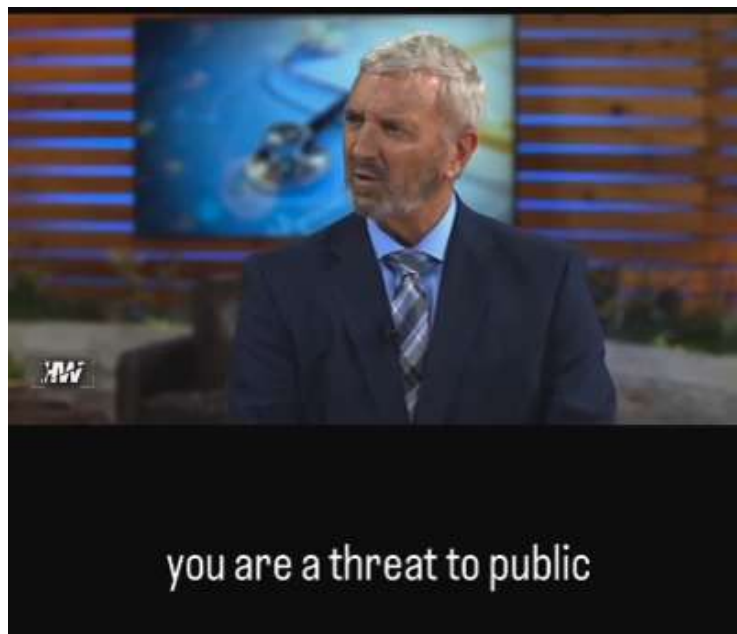

South Africa's ambassador to France, Nkosinathi Emmanuel "Nathi" Mthethwa, was found dead on September 30, 2025, outside the Hyatt Regency Paris Étoile hotel. He was 58 years old. Mthethwa's wife reported him missing on September 29 after receiving a worrying text message from him. An investigation revealed that he had booked a room on the 22nd floor of the hotel, where a secured window had been forced open ^{1 2}.

The circumstances surrounding his death are still under investigation, but according to French newspaper Le Parisien, Mthethwa's death is believed to be a suicide. A source close to the case mentioned that the ambassador suffered from depression, which might have contributed to his passing ².
