US Government Says Ingestible Fluoride Not Safe For Most Children

The US Food and Drug Administration has announced it is restricting the sale of ingestible fluoride, such as tablets and drops, for children under three, and older children not at high risk of dental decay. The FDA's press release states that there is growing research pointing to fluoride's neurotoxicity even at levels thought of as low. and it is now known that fluoride interferes with the gut

microbiome. “The microbiome is increasingly recognized to be central to a child’s health and development,” according to FDA Commissioner Marty Makary, M.D., M.P.H.

The question has to be asked – If ingesting fluoride is not safe for young children, then why is it added to the drinking water? It is now plain for everyone to see that fluoridation should only be part of a Monty Python skit. Obviously, if fluoride is not safe to ingest, then it is not safe to add it to the drinking water.

The backlash against the Broadcasting Standards Authority (BSA) has been fierce and deserved. Its attempt to claim jurisdiction over The Platform has

triggered outrage with ACT Leader David Seymour saying Parliament “never asked” the BSA to police the internet, while NZ First Leader Winston Peters accused the Authority of “acting like some Soviet-era Stasi.”

Most of the criticism from legal experts, journalists and politicians has focused on how the BSA overstepped: the botched process, the legal overreach, the arrogance of claiming powers it doesn’t have. And that’s fair criticism. But it misses the elephant in the room: the Government itself is preparing to do the same thing that the BSA proposed. That’s why this matters. The BSA episode feels like a dress rehearsal for something bigger.

The Dress Rehearsal

When the BSA declared that The Platform is a “broadcaster,” it wasn’t just misinterpreting the law; it was a sonar ping to test how far public tolerance will stretch for Government control of online speech. Read the rest [here](#).

Political

- Danielle Smith and other Conservatives are calling on Ottawa to use the notwithstanding clause after the Supreme Court of Canada scrapped mandatory minimum sentences for accessing child pornography. The country's top court [ruled on Friday](#) to dismantle mandatory one-year jail sentences for possessing child pornography, claiming it unconstitutional and prevented them from being lenient on pedophiles. Ezra [Levant similarly explained](#) why the Charter of Rights has a notwithstanding clause. "Because a 5 to 4 ruling of Supreme Court judges — a single judge holding the balance — cannot be enough to effectively decriminalize child pornography, against the beliefs of 90%+ of Canadians," he said. - <https://www.thecountersignal.com/p/smith-kenney-urge-ottawa-to-invoke>
- [Sen. Rand Paul](#) is demanding that U.S. Director of National Intelligence Tulsi Gabbard turn over documents showing connections between the U.S. Intelligence Community and key virologists and public health officials, including [Dr. Anthony Fauci](#), as part of his investigation into the origins of COVID-19. Paul, chairman of the U.S. Senate Committee on Homeland Security and Government Affairs, [revealed documents](#) showing that University of North Carolina virologist Ralph Baric, Ph.D., communicated with "*members of the U.S. intelligence community ... well before the outbreak of the global pandemic.*" Paul's letter asks Gabbard to release U.S. intelligence communications with Fauci, and former NIH Director [Francis Collins](#). The letter also asks for communications involving [Peter Daszak, Ph.D.](#), former president of the [EcoHealth Alliance](#), which received federal funding for gain-of-function research. - <https://childrenshealthdefense.org/defender/sen-rand-paul-demands-intelligence-records-fauci-baric-covid-origins>

Legal

- Tamara Lich has filed an appeal against her mischief conviction for participating in the 2022 Freedom Convoy. After nearly three years of legal harassment, 49 days in jail, and now a sentence of 18 months house arrest, Lich refuses to back down. Lawrence Greenspon, one of Canada's top lawyers, will handle the appeal. Her appeal is built on two simple, undeniable facts. Even if there were minor issues with the convoy, the trial judge ignored Tamara's freedom of expression under the Charter. - Go to www.HelpTamara.com

- Two Canadians are continuing to seek justice years after Trudeau's travel vaccine mandates, arguing no government should force the surrender of one Charter rights. Despite their original cases being dismissed, Harrison and Rickard contend that legal principles remain unresolved. Their 15,000 pages of evidence, including internal communications, allegedly show that the Public Health Agency of Canada and Health Canada did not recommend the travel ban. Rickard explained that the government sought scientific justification for an already decided policy. Dr. Celia Lourenco's cross-examination revealed that PHAC and Health Canada provided no scientific evidence to support Trudeau's desired actions. These individuals are determined to prevent the unprecedented tyranny of covid mandates being implemented again by any future government. -

- Two New York families are suing their school districts in federal court, alleging that district officials unlawfully denied their children's medical exemptions. One case involves an 11-year-old with a documented history of life-threatening reactions to vaccines. The other case concerns a 17-year-old who has a documented personal history of severe vaccine-induced airway constriction, a strong family history of autoimmune disorders, and a life-threatening latex allergy. The lawsuits ask the court to issue a preliminary injunction to allow these children to return to school and to recognize their medical exemptions as valid. The plaintiffs also seek compensation for damages, including lost educational opportunities and emotional distress. When one of the families, acting under extreme duress from these threats, attempted to comply with the District's vaccination demands, they were turned away by multiple medical providers who refused to administer the vaccine, citing the clear and documented danger to the child's health. The lawsuit also alleges that the district responded to the request for an exemption with a coordinated campaign of intimidation and threats involving Child Protective Services (CPS). The county health department warned the mother that CPS could intervene if the child remained unvaccinated. Medicine/Health

- Dr. William Makis announced this week – *“We have started a Research Project in FLORIDA that could END the mRNA Vaccine Platform forever. “For the first time, long-term IMMUNE SYSTEM FUNCTION can be directly compared across four key exposure groups within high-quality electronic medical record datasets from thousands of real patients — capturing every possible combination of vaccination and infection status... - ♦ A 13-year-old heart patient is now eligible for a transplant after a conflict with Cincinnati Children’s Hospital has been resolved. Adaline Deal has a rare heart condition, but was initially not allowed on the transplant list because she did not have her flu and [COVID-19 vaccines](#). The mother, Jeneen Deal, says Adaline’s doctors waived the vaccine policy for her individual case. The doctors still informed them of the risks. They said with her being unvaccinated, she’ll be immunosuppressed. And the mother said, *‘Yes, we understand that, but we are confident that she doesn’t need those vaccinations.’ They said, ‘Okay, we’ll work with you.’*” - <https://childrenshealthdefense.org/defender/ch-family-fights-for-bill-stopping-hospitals-denying-transplants-vaccines>
- ♦ After a five-month review, the U.S. Food and Drug Administration announced last Friday that it would restrict ingestible fluoride tablets and drops prescribed to children. The agency sent notices of intent to take enforcement action against four companies that produce these ingestibles and advised clinicians not to use such products in children under age three or in older children. In its [review](#), the FDA reported that 500,000 prescriptions for ingestible fluoride were filled in 2024, or 1.2 million when supplements are included. The FDA’s action targets unapproved, ingestible sodium- fluoride drops and tablets historically given to infants and toddlers. It does not change the status of fluoride toothpaste or varnish, and it does not adjudicate community water fluoridation. - <https://www.themahareport.com/p/the-fda-quietly-changes-ingestible>
- ♦ At the [Minamata Convention](#) on Monday in Geneva, Switzerland, Secretary of Health and Human Services Robert F. Kennedy Jr. called on the Convention to make the use of mercury in vaccines “history.” *“Now that America has removed mercury from all vaccines, I call on every global health authority to do the same – to ensure that no child, anywhere in the world, is ever exposed to this deadly neurotoxin again,”* Secretary Kennedy said. The Secretary noted that the Minamata Convention has been working for decades to reduce mercury pollution and exposures, *“In 2010, as the treaty took shape, negotiators made a major exception – Thimerosal containing vaccines were carved out of the regulation,”* Kennedy said. *“The same treaty that began to phase out mercury in lamps and cosmetics, chose to leave it in products injected into babies, pregnant women, and the most vulnerable among us. We have to ask ‘why?’”* Kennedy noted the double [Thimerosal: Let the Science Speak](#), which describes thimerosal as a potent neurotoxin, a mutagen, a carcinogen,

- Former CDC Director Dr. Robert Redfield has written a book Redfield's Warning: What I Learned (But Couldn't Tell You) Might Save Your Life. Redfield details what went on behind the scenes of the federal response to the Covid pandemic. It is not a pretty picture. Politics and personalities – not science – often ruled the day. Redfield sees Robert F. Kennedy Jr.'s commitments to gold-standard science and transparency as keys to a more successful future for public health in the United States. *"The days of believing authorities because they are in an authoritative position are over,"* Redfield notes. *"The way to convince people to follow recommendations is to provide evidence that the recommendations are not arbitrary or politically motivated but based on science. We need to provide context. We need to admit when we are wrong. We need to be willing to change as the data changes. Policy recommendations are never going to be a perfect science. Telling It Like It Is / Truth Bombs

- Texas recently passed the App Store Accountability Act. It requires app stores like Apple and Google to verify the age of users; to implement parental consent systems for minors; and to give parents more control over what their kids can download. On the surface, this sounds like a win for families. But here's why this matters to everyone... Because laws like this don't stay confined to their original purpose. They set precedents. They create infrastructure. They normalize systems of control that can be expanded later. Every time we legislate in the name of safety... We risk growing the surveillance state. Sometimes that's the price. But it should never be ignored.
- Dr Andrea Wagner wrote in an X post: *"I've lived in Canada for 18 years now—long enough to shed my illusions, but not long enough to stop being stunned by what I see. When I first arrived, I thought Canadians were polite—too polite, almost unbearably so. The endless "sorrys," the soft tones, the careful avoidance of conflict. It felt harmless at first, even charming in contrast to the bluntness of my Hungarian, German, or Eastern European roots. But then I realized something deeper, something darker: Canadians apologize too much for the meaningless, and never for what matters. They say sorry when they bump into you, when they're five seconds late, when they interrupt. But they do not apologize when they abuse power. They do not apologize when they destroy someone's life through bureaucracy, cowardice, or complicity. They do not apologize when they ostracize courage, when they punish truth, when they betray integrity. They apologize for nothingness—and when the moment*

demands moral courage, they hide. What's left is a culture that confuses niceness with goodness, procedure with justice, and quiet compliance with peace. Canada's greatest tragedy is not its cruelty, but its cowardice." -
