

Free Speech Union: Two Futures: One We're Winning, One We Need to Fight

Every so often, we get to send you an email about a positive development for free speech in New Zealand. Today is one of those moments.

On Wednesday, the University of Auckland adopted a new Freedom of Expression Statement, committing to institutional neutrality and reaffirming that universities are supposed to host debates – not decide them in advance.

And make no mistake: this didn't happen by accident. It follows the passage of the Education and Training Amendment Bill (No 2) – legislation we supported and helped shape through the Inter-University Committee on Academic Freedom.

When the Bill passed last month, we said we hoped it would help turn universities back toward open inquiry. Auckland has just become the first to do it.

Auckland University: A Win for Free Speech

Debate is essential, even when it's uncomfortable.

The university stays neutral, rather than jumping in and taking sides because somebody is upset.

Neutrality isn't about avoiding conversations – it's about making sure everyone can participate without worrying the institution has already picked a side.

So yes, this is a genuine win. The process, led by Distinguished Professor Sir Peter Hunter and a Senate working group, actually modelled the kind of dialogue universities should be championing.

When Jacinda Ardern was entrusted with a US \$20 million philanthropic grant by Melinda French Gates, it sparked worldwide interest. The fund was designed to support initiatives that uplift women's health, education, leadership, and safety. Yet months later, one question continues to linger: where did the money actually go?

So far, no public record has detailed how Ardern has allocated the funds. Unlike government spending, private re-grant philanthropy isn't required to disclose recipients unless the donor or the supported organisations choose to reveal it. This means Ardern may still be assessing partners, quietly distributing funds, or preparing a coordinated announcement with the chosen charities.

What we do know is the intent: this money is meant to back innovative, urgent, transformative work for women and girls — a space Ardern has championed since leaving politics. Whether it

supports education projects, domestic violence services, health initiatives, or leadership programmes, the impact could be significant.

WINS OF THE WEEK

Political

The City of Calgary has passed a new flag policy. City Hall flag displays are now limited to Canadian, provincial and municipal flags. When introducing the motion, Councillor Dan McLean explained that what began as a unifying gesture has become a source of division. *“In recent months, this practice has been used in ways that I’ve seen have inflamed tensions. As a municipal government, we have a responsibility to ensure that the spaces and ceremonies we oversee reflect neutrality, unity and respect for all Calgarians.”* He added that flag raisings should be limited to symbols that unite all Calgarians. Legal

In a key victory for the Trump administration, a D.C. circuit panel issued an order on Tuesday dissolving the stay on Secretary of War Pete Hegseth’s ban on transgender-identifying service members in the military. In the 2-1 ruling, the court stated that the lower court’s administrative stay neglected to grant Hegseth appropriate deference. *“The D.C. Circuit confirmed that the United States military is not a social experiment, and the Secretary of War is who sets military standards – not left-wing activists.”* Trump stated: The *“Armed Forces have been afflicted with radical gender ideology to appease activists unconcerned with the requirements of military service like physical and mental health, selflessness, and unit cohesion.”* - <https://www.lifesitenews.com/news/exclusive-pentagon-tells-lifesite-that-courts-ruling-on-military-transgender-ban-a-huge-victory>

Florida Republican Attorney General James Uthmeier has filed a lawsuit against the [American Academy for Pediatrics](#) (AAP), the so-called [World Professional Association for Transgender Health](#) (WPATH), and the [Endocrine Society](#), accusing them of deceiving the public on the safety of “gender transition” practices on confused minors. [The suit](#) alleges that, for the sake of their “ideology and financial incentives,” the named organizations *“developed a treatment protocol that irreversibly alters children’s bodies to conform to their anxieties”* rather than *“attempting to resolve the underlying causes of psychological distress.”* *“There has never been any credible evidence for any of these recommendations,”* the suit maintains, but the organizations successfully created public perception to the contrary *“by continuing to reference one another over an extended period of time.”* The \$4.1 billion sex intervention industry violates Florida’s Deceptive & Unfair Trade Practices Act and “constitutes a pattern of racketeering activity under the Florida Racketeer Influenced & Corrupt Organization Act. Florida is seeking \$1 million fines per organization, a block on repeating their false claims in the future, and additional \$10,000 fines per each instance of *“transmitting false or misleading claims about the safety, reversibility, or efficacy of sex interventions.”* - <https://www.lifesitenews.com/news/florida-sues-top-medical-groups-for-reprehensible-promotion-of-child-gender-transitions>

A jury in Los Angeles Superior Court awarded \$40 million to two women who filed lawsuits alleging that Johnson & Johnson's talcum-based baby powder led to their ovarian cancer after decades of use. The jury ruled that the company failed to warn consumers about the known dangers of its talc-based products. President Donald Trump has filed a defamation lawsuit against the British Broadcasting Corporation, alleging that the UK's state-backed broadcaster deliberately edited his words to falsely portray him as inciting violence. [The 33 page suit](#), filed in U.S. federal court, \$10 billion in damages and cites internal whistleblower documents, leadership resignations, and a documented pattern of prior misconduct to argue that the edit was not an error — but an intentional act of malice. The lawsuit alleges not mere negligence, but institutional intent. Whether the lawsuit ultimately succeeds or fails on the merits, it has already accomplished something unprecedented: it has transformed what was once dismissed as "media controversy" into a matter of legal accountability.

Children's Health Defence is suing the Department of Defence over 'sham' religious exemption policies. The lawsuit accuses the U.S. military of denying virtually all religious accommodation requests from service members and recruits. CHD alleges the military's policy for granting religious exemptions to recruits is "largely theater." "*Our military members literally put their lives on the line to preserve our freedoms, one of the most essential of which is free exercise of religion,*" said CHD General Counsel Kim Mack Rosenberg. The House of Representatives voted on Dec. 17 to pass a bill that would criminalize transgender-related treatments for minors, including surgical procedures and puberty blockers. The [bill](#), called the "Protect Children's Innocence Act" was approved in a 216–211 [vote](#) and will now advance to the Senate. "*This puts a stop to the radical left's assault on kids! Children are NOT experiments. No more drugs. No more surgeries. No more permanent harm. We need to let kids grow up without manipulation from adults to make life-altering decisions,*" Greene [stated](#). The proposed legislation prohibits transgender-related treatments—including puberty blockers, hormonal treatments, and surgical procedures—for individuals under the age of 18. Medicine/Health

In a moment that marks a historic rupture with more than a decade of ideologically driven medical policy, the U.S. Department of Health and Human Services formally declared this

week that so-called “gender-affirming care” for minors constitutes chemical and surgical mutilation—and will no longer be permitted, funded, or protected by the federal government. What had long been marketed as compassionate, evidence-based care was today officially reclassified by the federal government as unsafe, ineffective, and outside professionally recognized standards of medicine. *“This is not medicine. It is malpractice.”* Said Secretary Robert F. Kennedy Jr. Dr. Oz delivered one of the most striking indictments of politicized medicine ever voiced from within HHS: *“You know what you get when you mix politics and medicine? Politics. There is no medicine left.”* FDA Commissioner Dr. Marty Makary stated: *“Let’s be honest, pushing transgender ideology on children is predatory. It’s wrong. And it needs to stop.”* Makary drew a sharp distinction between legitimate medical care and what he described as an ideologically driven belief system imposed on children—often without parental knowledge or consent. - <https://sayerji.substack.com/p/breaking-hhs-draws-red-linegender>

Dr Robert Malone writes: *“HHS has terminated multiple federal grants to the American Academy of Pediatrics (AAP), totaling around \$18-20 million and for good reason. The AAP has recommended pediatricians practice gender affirming care for children and from summer 2021 and thereafter, the AAP recommended that all students and school staff age 2 and older wear masks in schools - even though there is no evidence that mask use would stop transmission. In 2025, the AAP issued its own COVID-19 vaccination guidance that diverged from federal policy, recommending COVID shots for all children 6–23 months old. This puts children at risk for myocarditis and other severe adverse events from these dangerous injections - injections that are not safe for children, do not stop transmission or infection. The AAP has lost touch with American families and children, advocating various fadish trends that have caused real physical damage to our youth. Thank you, Sec. Kennedy and HHS for taking this positive and important step to ensure the health of our children.”*

The family of 14-month-old Violet Skye Rodela, who died 19 days after getting an MMR and other routine vaccines, won compensation from the National Vaccine Injury Compensation Program for the toddler’s death. Truth Bombs

Without fanfare, [YouTube quietly reinstated](#) two voices it once silenced as purveyors of “misinformation” during the pandemic: activist Ronnie “Rizza” Islam and Sayer Ji – founder of [GreenMedInfo](#) and co-founder of [Stand For Health Freedom](#). Rizza and Sayer Ji were part of the notorious “Disinformation Dozen.” YouTube now admits neither of them violated the platform’s rules. The people once labeled ‘dangerous’ were telling inconvenient truths. In a remarkable twist, Alphabet is now asking for protection from censorship under the European Union’s new Digital Services Act (DSA). The company warned that the DSA could be interpreted to require platforms to remove lawful content — and that this posed a threat to free expression both inside and outside of the EU. The irony is unmistakable. After spending years suppressing lawful speech under government pressure, Big Tech is now seeking protection from the very overreach it once enabled.

Kirralie Smith, an Australian women’s rights advocate, has been ordered by a New South Wales court to pay \$95,000 AUD (over \$63,000 USD) to two trans-identifying men for the crime of “unlawfully vilifying” them by correctly referring to them as male. “*It is disappointing that the word ‘woman’ has been redefined to include males and that the words ‘violence’ & ‘vilification have been applied to speaking the truth about information in the public domain,*” said Smith. “*Australians should be very concerned about their freedoms. Women have effectively been erased from law and attempts to advocate regarding public policy are shut down for the sake of the feelings of a few.*” - <https://www.lifesitenews.com/blogs/australian-woman-ordered-to-pay-95k-to-transgender-men-for-misgendering>

Social media is no longer social. Today, major platforms are governed by predictive systems designed to maximize engagement, not relationship. What fills the feed is less conversation than stimulus: outrage, affirmation, fear, desire—whatever keeps attention from wandering. What we still call “social” media now functions more like a personalized broadcast stream. Users participate less in shared communities and more in

private feeds optimized for engagement. The experience is individualized, continuous, and detached from the ordinary rhythms of human interaction. But when a space stops functioning as genuinely social, it no longer teaches people how to relate to one another.


