*Never before in humanity has there been such a casting; we now know who the resisters are on planet Earth.*





## Free Speech Includes The Right To Protest Not The Right To Intimidate



From Free Speech Union: The confrontation between Destiny Church supporters and a lawful Sikh Nagar Kirtan parade in South Auckland raises questions about where legitimate protest ends and intimidation begins, says Jillaine Heather, Chief Executive of the Free Speech Union.

"Peaceful protest and counter-protest are crucial elements in a functioning democracy," said Heather. "New Zealand's strength is that we protect everyone's right to express their views, even when those views make others uncomfortable. That includes Brian Tamaki's right to disagree with immigration policy or criticise other religions."

"But physically interfering with parades, speeches, or communities exercising their rights to freedom of expression and association crosses a line. When 50 people form a barrier to stop a Nagar Kirtan procession, that's not counter-protest – it's obstruction that limits others' legal expression."

"The test is simple: can both groups exercise their rights at the same time? A Sikh community walking in lawful parade doesn't prevent Destiny Church from stating its views. But physically blocking that parade does prevent Sikhs from exercising theirs. Read the rest of this article [here](#).


##### United States of America

Below are links to copies of the contracts entered into by the US government for technologies to combat the COVID-19 pandemic. KEI is updating this page as we gain access to more contracts, and less redacted versions. Agreements related to the Medical CBRN Defense Consortium (MCDC) whose agreements are executed by Advanced Technology International (ATI) are noted with "(via ATI)".

KEI has also created a US COVID-19 contract spreadsheet to track metadata of the agreements, as well as to compare the terms contained therein for intellectual property rights, data, and other topics. (Note: At this time, this spreadsheet is being continually updated.) KEI maintains a separate page of US government contracts concerning needle and syringe production related to the COVID-19 response.



## WINS OF THE WEEK

### **From: NZ Rising's Sister Organisation in Canada, Freedom Rising:**

#### **Political**

The Trump administration has withdrawn the United States from 66 international organizations, conventions and treaties this week that it said go against the country's interests. Thirty-one entities were tied to the United Nations. *"The Trump Administration has found these institutions to be redundant in their scope, mismanaged, unnecessary, wasteful, poorly run, captured by the interests of actors advancing their own agendas contrary to our own, or a threat to our nation's sovereignty, freedoms, and general prosperity,"* according to Secretary of State Marco Rubio. The State Department was ordered to review the international intergovernmental organizations that *"no longer serve American interests"* in February 2025, per an executive order signed by President Donald Trump. Rubio accused many entities of being *"often dominated by progressive ideology and detached from national interests."* <https://www.theepochtimes.com/us/us-to-withdraw-from-66-international-bodies-treaties-5967752>

*Slovenia passed a constitutional amendment on December 1, 2025 to protect cash as legal tender. Slovenian citizens got the cash ball rolling with a social media campaign and grassroots petition in 2023 that forced the hand of legislators. MPs cited a variety of reasons for their support of cash payments as a "fundamental right," including autonomy, privacy, and reliability during emergencies. "In any scenario that disrupts the digital flow of money—the physical banknote, often dismissed as outdated, becomes the ultimate medium of exchange." Slovenian parliamentarians' new constitutional amendment is "a huge step toward protecting not only the use of physical money, but also freedom, security, and sovereignty." - <https://needtoknow.news/2026/01/pushback-of-the-week-slovenia-protects-cash/>*

*Several pro-life and pro-family amendments are advancing to the Conservative Party of Canada National Convention. Conservatives will convene in Calgary on January 29 – 31 to discuss various policy resolutions, including one to allow the party to advance pro-life legislation and another protecting children from irreversible gender transitions. The proposal seeks to abolish Policy 86, which currently states that a Conservative government will not support pro-life legislation. Similarly, Conservatives are advancing the "Parental Right to Body-Affirming Therapy for Kids" resolution to oppose the current ban on "conversion therapy." Under the Liberals' policy, parents can be punished by up to five years in jail for discouraging their gender-confused child from believing that they are the opposite sex. "The Conservative Party believes that the family unit is essential to the well-being of individuals and society, because that is where children learn values and develop a sense of responsibility," the policy declared. The convention is also advancing several other socially-conservative policy resolutions, including creating euthanasia-free sanctuary spaces, enshrining conscience protection for institutions, protecting "advancement of religion" as a charitable purpose, and banning digital ID. - <https://www.lifesitenews.com/news/pro-life-pro-family-resolutions-to-be-discussed-at-conservative-national-convention>*

*North Carolina House Bill 805, which went into effect January 1, officially recognizes only two sexes in all official state proceedings. The bill defines "biological sex" as the "biological*

indication of male and female in the context of reproductive potential or capacity, such as sex chromosomes, naturally occurring sex hormones, gonads, and non-ambiguous internal and external genitalia present at birth, without regard to an individual's psychological, chosen, or subjective experience of gender." The bill also bans federal funding of gender transitions for minors, allows parents to opt their children out of class material that contradicts their religious beliefs, requires parents to be given access to school library books for review, and requires schools to provide separate sleeping quarters for male and female students on overnight trips. The bill was vetoed by North Carolina Governor Josh Stein, however, the North Carolina General Assembly voted to override Gov. Stein's veto.

On December 8, Randolph County Commissioners voted to dismiss the public library's board of trustees over the board's decision to keep a transgender-themed book in the children's section. The book in question, titled *Call Me Max*, is about a young girl who wants to change her name to Max to better express her perceived "gender identity." The author is "Kyle" Lukoff, a female who identifies as a "transgender male." Other literary works by Lukoff include the Too Bright to See book series, which features another transgender 11-year-old character named Bug. Canada has been relieved of Chrystia Freeland thanks to Ukraine's Zelensky. Freeland has been hired by Ukraine to assist in providing economic advice to that country. It seems her track record in Canada made her a good candidate. Freeland's last day in Parliament was on Friday. We ought to thank Zelensky for taking her off our hands.

### **Medicine/Health**

Federal health officials today outlined sweeping changes to the U.S. childhood immunization schedule. The new recommendations reduce the number of vaccines recommended as routine for all children from 17 to 11. HHS said the change follows a directive from President Donald Trump instructing the agency and the Centers for Disease Control and Prevention to review whether other developed nations protect children more effectively. U.S. Health Secretary Robert F. Kennedy Jr. said. "After an exhaustive review of the evidence, we are aligning the U.S. childhood vaccine schedule with international consensus while strengthening transparency and informed consent." After reviewing peer-country schedules and the scientific evidence underlying them, federal health leadership acknowledged that we are hyper-vaccinating our children. The result is a dramatically smaller routine childhood vaccine schedule, cutting approximately 55 routine doses. This marks the largest rollback of routine childhood vaccination in U.S. history. This is a major victory — even as serious safety concerns remain for the vaccines that continue to be recommended. The following vaccines are no longer recommended for all children by default: COVID-19, Influenza, Hepatitis A, Hepatitis B (including removal of the universal birth dose if the mother is HBsAg-negative), Rotavirus, Meningococcal ACWY, Meningococcal B. Human Papillomavirus has been reduced from two doses to one.

The US federal government has announced it will stop paying physicians based on the number of patients they vaccinate, and is urging state health agencies to stop using similar financial incentives. Pediatrician Dr. Michelle Perro said - “Any time a clinician’s compensation is tied to a specific medical decision, especially one involving children, families reasonably ask, ‘Is this recommendation for my child, or for a metric?’ Even the appearance of a conflict can erode trust, and trust is the foundation of pediatric care and informed consent.” Parents have complained for years that financial incentives distort medical judgment, leading to high-pressure tactics around childhood vaccinations. Some say doctors push shots parents believe are unnecessary or unsafe. Others report being dismissed from pediatric practices altogether if they decline vaccines. According to a 2021 paper co-authored by Lyons-Weiler and Dr. Paul Thomas refusal of CDC-scheduled vaccines by patients resulted in projected annual losses exceeding one million dollars in one practice. The incentives are designed to increase childhood vaccination rates, regardless of the need. - <https://childrenshealthdefense.org/defender/doctors-will-no-longer-receive-financial-rewards-vaccinating-kids-cms>

The Trump administration on Jan. 7 unveiled new dietary guidelines that will affect the food served to millions of Americans. The 10-page guidelines emphasize protein, dairy, “healthy fats,” fruits, vegetables, and whole grains. Health Secretary Robert F. Kennedy Jr.’s message was simple: eat real food. The new guidelines encourage meat, eggs, whole milk, and effectively inverts the previous food guide pyramid. Kennedy called the changes the “most significant reset of federal nutrition policy in history.” The guidelines will become the default for what’s served to schoolchildren, the military, veterans, the elderly and low-income families that participate in federal programs like WIC and Head Start. Kennedy said the Guidelines affirm that food is medicine. - <https://www.theepochtimes.com/us/trump-admin-releases-new-dietary-guidelines-5967430>

RFK Jr. explains how gluten allergies exploded in 2006 due to spraying of glyphosate on wheat before harvest. In 2006, Monsanto advised farmers to spray its Roundup Ready pesticide, with the active ingredient glyphosate, on wheat so that it would act as a dessicant to dry it out and prevent mold. Robert Kennedy Jr. said: “It was so popular that about 85 % of the Roundup that has been used in history has been used since 2006. A large part of that is as a desiccant. ## Legal

A Maine mother has asked the US Supreme Court to hear her parental rights case alleging that her daughter’s school concealed the child’s “gender transition” from her. The mother, Amber Lavigne, said she had no idea that a school social worker advised her 13-year old daughter about “gender transitioning.” In December 2022, Lavigne found a chest binder while cleaning her daughter’s room, which was revealed to have been given to her by the School social worker. “This situation is really about my parental rights being violated,” stated Lavigne, adding, “It’s about a social worker who had never even had a conversation with me encouraging my child to keep secrets from me.” Lavigne was originally denied an appeal of the school’s parental rights violation when the First Circuit Court of Appeals refused to hear her claim, thus her request to the Supreme Court.

In another absurd development, a federal judge ruled this week that a coalition of major medical organizations can move forward with a lawsuit challenging vaccine policy changes under U.S. Health Secretary Robert F. Kennedy Jr. Judge Brian Murphy of the U.S. District Court for the District of Massachusetts rejected the government's bid to dismiss the case. Murphy ruled that the plaintiffs — which include the American Academy of Pediatrics have legal standing to sue. Mack Rosenberg, general counsel for Children's Health Defence stated: “It is telling that one of the alleged financial injuries to doctors discussed in the judge's order is that pediatricians will have to spend more time discussing vaccines with families and thus will not be able to see as many patients each day.” “In other words, doctors may have to have discussions with patients so that families can have informed consent.” Rosenberg said the court's reasoning “tacitly admits that, in many pediatric practices, currently those discussions are not taking place in a meaningful way and families are not having their concerns addressed.” Plaintiffs in the case include the AAP, the American College of Physicians, the American Public Health Association, the Infectious Diseases Society of America, the Massachusetts Public Health Association, the Society for Maternal-Fetal Medicine and a pregnant physician identified as “Jane Doe,” who claims she faces “barriers to access to the vaccine.” Richard Hughes, lead counsel for the plaintiffs served as Moderna's vice president of public policy from 2020 to 2022, during the rollout of the company's COVID-19 vaccine, Spikevax. Before that, he worked for Merck.
